This notification is being filed on behalf of Doctor's Best, Inc. which is the manufacturer of the product which bears the statements identified in this notification. Its business address is: 1120 Calle Cordillera, Suite 101, San Clemente, CA 92673. This notification is being made pursuant to Section 6 of DSHEA and Rule 21 C.F.R. §101.93. The dietary supplement product on whose label or labeling the statements appear is High Absorption CoQ10.

The text of each statement for which notification is now being given is as follows:

Statement 1: CoQ10 is a nutrient that supports heart function and promotes energy production in cells.

Statement 2: Boosts cellular energy production.

Statement 3: Essential to life, CoQ10 works at the cellular level to produce metabolic energy in the form of ATP.

Statement 4: Strengthens and protects the heart.

Statement 7: The reduced form of CoQ10, ubiquinol-10, has been found to protect LDL against peroxidation by free radicals more effectively than vitamin E.

Statement 9: Benefits the gums.

Statement 10: CoQ10 has a broad range of applications, stemming from its ability to support the heart and cardiovascular system, cellular energy production, liver function, nerves and muscles.


