



Directions for Use:




1. Open package and clean under nails with the nail pick provided. Nails should be maintained with a 1 millimeter free edge.



2. Wet hands and forearms to the elbows with warm water.


3. Wet sponge and squeeze to work up lather.



4. Scrub thoroughly for 3 minutes paying particular attention to the nails, cuticles, and interdigital spaces. Use the brush side of the product to clean the nails, cuticles, and interdigital spaces. Use the sponge side of the product when scrubbing the hands and forearms.

5. Rinse thoroughly with warm water and repeat scrub for an additional 3 minutes using the sponge side of the product only.

6. Rinse thoroughly and dry with a sterile towel.
