Dear Mr. Reinauer:

During an inspection of your vessel watering point facility located at 1983 Richmond Terrace, Staten Island, New York on April 10, 2000, our investigator observed violations of the Public Health Service Act and implementing regulations for the Control of Communicable Diseases and Interstate Conveyance Sanitation (Title 21, Code of Federal Regulations, Parts 1240 and 1250).

At the conclusion of the inspection, our investigator presented to Mr. Frank Finnan, Yard Superintendent, a list of Inspectional Observations, Form FDA 483 (copy attached), and an Inspection Summary for Vessel Watering Point Sanitation, Form FDA 2521 (copy attached). The findings were discussed with Mr. Finnan.

The following deficiencies were observed during the inspection:

- There is no backflow preventer device in the line leading to the hydrant outlet on pier 1 (items # 5 and 6 on Form FDA 2521).
- A non-potable water hydrant is located on the same pier with a potable water hydrant. These water hydrants are not clearly marked with signs reading "Potable Water" and "Unfit for Drinking" (item # 17 on Form FDA 2521).

As a result of the above violations, a "Provisional" classification has been assigned for a period of thirty (30) days at which time a reinspection will be conducted. If significant improvement has not been made at that time, a "Not Approved" classification will be justified.
