WARNING LETTER

Dear Mr. Lee:

We inspected your firm located at 15806 Highway 99, Lynnwood, Washington, on November 28 and 29, 2000, and found that you have a serious deviation from Title 21 of the Code of Federal Regulations (21 CFR) Part 123 - Fish and Fishery Products (Seafood HACCP regulations). An FDA 483 form (copy enclosed) listing the deviation was presented to you at the conclusion of the inspection. This deviation, which was previously brought to your attention, causes your seafood based sushi products to be in violation of Section 402(a)(4) of the Federal Food, Drug, and Cosmetic Act (the Act). You can find this Act and the Seafood HACCP regulations through links in FDA's homepage at [www.fda.gov](http://www.fda.gov).

The deviation is as follows:

1. You must have a HACCP plan to control any food safety hazards that are reasonably likely to occur, to comply with 21 CFR 123.6(b). Your firm does not have a HACCP plan for your seafood based sushi products to control the food safety hazard of pathogens.

This letter may not list all the deviations at your facility. You are responsible for ensuring that your processing plant operates in compliance with the Act, the Seafood HACCP regulations and the Good Manufacturing Practice regulations (21 CFR Part 110). You also have a responsibility to use procedures to prevent further violations of the Federal Food, Drug, and Cosmetic Act and all applicable regulations.

We may take further action if you do not promptly correct these violations. For instance, we may take further action to seize your product(s) and/or enjoin your firm from operating.


Please respond in writing within three (3) weeks from your receipt of this letter. Your response should outline the specific things you are doing to correct this deviation. You may wish to include in your response documentation or other useful information that would assist us in
