Subject: Finding of No Significant Impact (FONSI) for Food Contact Substance Notification (FCN) 2038: Benzenesulfonic acid, 2-[2-(2,4-diamino-1,6-dihydro-6-oxo-5-pyrimidinyl)diazenyl]-5-methyl- (CAS Reg No. 1021701-36-9).

Notifier: BASF Schweiz AG

Attached is the FONSI for FCN 2038, which is for the use of Benzenesulfonic acid, 2-[2-(2,4-diamino-1,6-dihydro-6-oxo-5-pyrimidinyl)diazenyl]-5-methyl- as a colorant in all food-contact polymers, except for use in contact with infant formula and human milk.

After this FCN becomes effective, copies of this FONSI, and the notifier's environmental assessment (EA), dated January 31, 2020, may be made available to the public. We will post digital transcriptions of the FONSI, and the EA on the agency's public website.

Please let us know if there is any change in the identity or use of the food-contact substance.

FINDING OF NO SIGNIFICANT IMPACT

Food Contact Substance Notification (FCN) 2038, submitted by BASF Schweiz AG for the use of Benzenesulfonic acid, 2-[2-(2,4-diamino-1,6-dihydro-6-oxo-5-pyrimidinyl)diazenyl]-5-methyl- (CAS Reg No. 1021701-36-9) as a colorant in all food-contact polymers The FCS is intended for use at a level not to exceed 0.5 percent by weight in polymers in contact with all foods under Conditions of Use A through H described in Tables 1 and 2 (https://www.fda.gov/food/packaging-food-contact-substances-fcs/food-types-conditions-use-food-contact-substances, accessed 2/21/2020). The FCS is not intended for use in contact with infant formula and human milk. Such uses were not included as part of the intended use of the substance in the FCN.

The Office of Food Additive Safety has determined that allowing this notification to become effective will not significantly affect the quality of the human environment and, therefore, an environmental impact statement (EIS) will not be prepared. This finding is based on information submitted by the notifier in an environmental assessment (EA), dated January 31, 2020. The EA was prepared in accordance with 21 CFR 25.40. The EA is incorporated by reference in this Finding of No Significant Impact (FONSI) and is briefly summarized below.

The FCS is intended for use as a colorant in all food-contact polymers. Food-contact articles containing the FCS will be widely distributed across the country. Post-consumer disposal of food-contact articles containing the FCS will be to landfills or municipal waste combustors (MWC) complying with 40 CFR Parts 258 and 60, respectively. No significant impact on the concentrations of and exposures to any substances in air, water, or soil are anticipated. Due to EPA's regulations governing landfills at 40 CFR Part 258, leaching into the environment by food-contact articles manufactured with the FCS is not anticipated. According to information in a confidential attachment to the EA, total annual emissions of greenhouse gases (GHG), including nitrous oxide (N2O), represented as CO2-equivalent (CO2-e) in metric tons (mT), will not cause any MWC facility to exceed the 25,000 mT GHG reporting threshold described in 40 CFR 98.2. Therefore, no significant impacts are expected from incineration of the FCS at MWC facilities. Thus, the use of the FCS as proposed is not reasonably expected to result in significant environmental impacts.

Use of the FCS is not expected to cause a significant impact on resources or energy. No mitigation measures are needed since no significant impacts are expected from use of the FCS. The alternative to not allowing the FCN to become effective would be the continued use of currently approved polymer colorants that the FCS would have replaced. Such action would have no significant environmental impact.

As evaluated in the EA, the proposed use of the FCS as described in FCN 2038 is not expected to significantly affect the human environment; therefore, an EIS will not be prepared.
