



NOTIFICATION PURSUANT TO SECTION 6 OF DSHEA
AND 21 CFR §101.93.

This notification is being filed on behalf of Doctor's Best, Inc. which is the manufacturer of the product which bears the statements identified in this notification. Its business address is: 1120 Calle Cordillera, Suite 101, San Clemente, CA 92673. This notification is being made pursuant to Section 6 of DSHEA and Rule 21 C.F.R. §101.93. The dietary supplement product on whose label or labeling the statements appear is High Absorption Calcium.

The text of each statement for which notification is now being given is as follows:

- Statement 1: Helps maintain strong, healthy bones.
- Statement 2: High Absorption Calcium is designed to meet the average adult's daily requirement for calcium, while supplying additional minerals known to play key roles in maintaining strong, healthy bones.
- Statement 3: Each mineral in High Absorption Calcium supports bone health.
- Statement 4: Zinc is an essential trace mineral that participates in bone metabolism.
- Statement 5: As dietary components, trace minerals such as zinc manganese and copper are important to bone health throughout life.
