

On May 20, 2002, CVM filed a Motion for Leave to Correct the Record. This motion sought to redact and/or withdraw various documents that contained confidential information that CVM had placed in the public docket in error. On June 4, 2002, Administrative Law Judge Davidson issued an Order requiring that "all Persons having copies of the original Exhibits Nos. G-341, G-682, G-837, G-872, G-916, and G-937 return the original and any copies of these documents to CVM's counsel by June 7, 2002." Order at 2. Bayer received copies of these documents on a CD-ROM and throughout the three months that Bayer has had possession of these documents, Bayer has distributed copies of the documents and copies of the CD-ROM to employees of the company both nationally and internationally. Because of the difficulty in retrieving these documents and CD-ROMs

within Judge Davidson's ordered timeframe, Bayer has consulted with both CVM and Judge Davidson regarding a request for an extension of time. By agreement of the Parties and Judge Davidson this deadline has been extended until Monday, June 10, 2002.




