Other than faxing the information on the safe handling label, I have decided to just email the information. The label must read as follows:

SAFE HANDLING INSTRUCTIONS: To prevent illness from bacteria, keep eggs refrigerated, cook eggs until yolks are firm, cook foods containing eggs thoroughly."

This label may replace "keep refrigerated" on the carton. This label statement must be shall be set off in a box by use of lines around it.

The label may appear on the top lid, or the display panel, or on the in-lid. Since the rule was first put into law without the option for use on the in-lid, you must request approval to use on the in-lid. To use this option you must write to the following requesting this option: Dr. Christine J. Lewis - Director of FDA's Office of Nutritional Products, Labeling and Dietary Supplements, Center for Food Safety and Applied Nutrition, 200 C Street, SW., Washington, D.C. 20204.

Actually we already have the first customer up in Canada. In the US it is still very slowly, because the most egg-grader are thinking in terms of eggs

as commodity product. Anyway, we do have some new customers; and I am in contact with the retailers SHOPRITE and ALBERTSONS to start a testsell in their stores. But there are still a lot of miles to walk!

I do have an inquiry for you! Is there some kind of regulations available of grading, packaging and labelling for shell eggs on the US-market? Actually I do have one for Canada available, but not for the US!
