Dear Mr. Thorvaldsson:

This is in response to your letter of August 22, 2007 to the Food and Drug Administration (FDA) pursuant to 21 U.S.C. 343(r)(6) (section 403(r)(6) of the Federal Food, Drug, and Cosmetic Act (the Act)). Your submission states that Source of Health, Inc. (dba Self Health Resource Center, Dr. Clark Store, and Dr. Clark Purity Products) is making the following claims, among others, for the following products:

Dr. Clark ParaZap

"Helps create an unfriendly environment for parasites"

"[H]alf of all Americans are infested with unwanted parasitic organisms (worms, larvae, and eggs."

"ParaZap Parasite Cleanse supports your body's own ability to destroy and remove these unwelcome "guests."

Dr. Clark Liver & Gallbladder Cleanse

"Helps remove unwanted gallstones that do not interfere with normal health."

Dr. Clark Kidney Cleanse

"Helps remove unwanted kidney stones that do not interfere with normal health."

21 U.S.C. 343(r)(6) makes clear that a statement included in labeling under the authority of that section may not claim to diagnose, mitigate, treat, cure, or prevent a specific disease or class of diseases. The statements that you are making for these products suggest that they are intended to treat, prevent, or mitigate diseases (i.e., gallstones, kidney stones, and parasitic infestations). These claims do not meet the requirements of 21 U.S.C. 343(r)(6). These claims suggest that these products are intended for use as drugs within the meaning of 21 U.S.C. 321(g)(1)(B), and that they are subject to regulation under the drug provisions of the Act. If your client intends to make claims of this nature, they should contact FDA's Center for Drug Evaluation and Research (CDER), Office of Compliance, HFD-310, Montrose Metro II, 11919 Rockville Pike, Rockville, Maryland 20852.

I talked with Dr. Kenneth Taylor about structure and function claims. Among other things, we discussed the label from Nature's Secret called Parastro, Para-Rid, and Para-Sweep. I also spoke to Gary Coody, R.Ph., who forwarded me your correct address and regulation 403(r)(6). I have also hired a label consultant. I have used all the advice gathered in the creation of the claims on the labels enclosed.

I am eager to follow the rules, therefore, in the case of you sending me corrective orders, please specify the paragraph of the rule that I am not following, this would be of great help for us to follow the rules when designing future labels. I have printed 700 of each label (about 6 months supply).

Dr. Taylor referred me to Mr. Fred Lockwood (fred.lockwood@fda.hhs.gov - tel - 301-827-1491) for advice on if I could enclose a separately packaged Epsom Salt bag in the liver cleanses kits. I contacted Fred on May 30th 2007. I talked to him several weeks after first contacting him however he never heard back from the people he asked about this for me. I assumed therefore that it was OK to include it in the kit.


