Dear Ms. Moenckmeier:

This is in response to your letter of November 14, 2001 to the Food and Drug Administration (FDA) pursuant to 21 U.S.C. 343(r)(6) (section 403(r)(6) of the Federal Food, Drug, and Cosmetic Act (the Act)). Your submission states that Enzymatic Therapy, Inc. is making the following claims for the following products marketed under the Enzymatic Therapy, Inc. and PhytoPharmica brand names:

The products **Enzymatic Therapy Candida Formula** and **PhytoPharmica Candimycin** use the claims "...fulfill the needs of a yeast-controlled program" and "Research suggests a link between these natural compounds and the balance of yeast in the body." These claims, including the names of the products in and of themselves (i.e., Candida Formula and Candimycin), are disease claims because they suggest that the products are intended to treat, prevent, or mitigate diseases, namely Candida yeast infections.

The products **PhytoPharmica Clinical Nutrients for 50-Plus Men** and **Enzymatic Therapy Doctor's Choice for 50-Plus Men** use the claim "...important to healthy blood cholesterol levels." In the preamble to the January 6, 2000 final rule on structure/function claims (see 65 FR 1000 at 1018), FDA stated that claims about the maintenance of normal cholesterol levels did not necessarily constitute implied disease claims. We stated, however, that because "many people think of cholesterol solely in terms of the negative role of elevated cholesterol in heart disease," in order to avoid implying that the product prevents or treats heart disease, a cholesterol maintenance claim would have to clarify that the product is only for maintenance of cholesterol levels that are already within the normal range. The claim for your product contains no such clarification, however. Therefore, FDA considers it to be an implied claim to prevent coronary heart disease by preventing the development of elevated cholesterol levels or reducing elevated cholesterol.

The products **PhytoPharmica Clinical Nutrients for Diabetics** and **Enzymatic**

**Therapy Doctor's Choice for Diabetics** use the claims "...to provide nutritional support for diabetics," "provides targeted nutrition support for individuals with diabetes," "Clinical Nutrients for Diabetics is a nutritional supplement specifically formulated to provide vitamins, minerals, and herbs for individuals with elevated blood sugar levels," and "Clinical Nutrients for Diabetics includes...Gymnema sylvestre, an herb long recommended for diabetics." These claims, including the names of the products because they use the term "diabetics" (i.e., Clinical Nutrients for Diabetics and Doctor's Choice for Diabetics), are disease claims. They are disease claims because they establish that the products are intended for use in the clinical management of patients with diabetes, including the clinical management of elevated blood sugar levels.

The products **PhytoPharmica Clinical Nutrients to Retain Healthy Cholesterol Levels**, **Enzymatic Therapy Doctor's Choice to Retain Healthy Cholesterol Levels**, **Enzymatic Therapy Flush-Free HexaNiacin**, **PhytoPharmica Flush-Free Niacin**, **Enzymatic Therapy GugulPlex**, and **PhytoPharmica GugulPlus** use the claim "...retain healthy cholesterol levels." In the preamble to the January 6, 2000 final rule on structure/function claims (see 65 FR 1000 at 1018), FDA stated that claims about the maintenance of normal cholesterol levels did not necessarily constitute implied disease claims. We stated, however, that because "many people think of cholesterol solely in terms of the negative role of elevated cholesterol in heart disease," in order to avoid implying that the product prevents or treats heart disease, a cholesterol maintenance claim would have to clarify that the product is only for maintenance of cholesterol levels that are already within the normal range. The claim for your product contains no such clarification, however. Therefore, FDA considers it to be an implied claim to prevent coronary heart disease by preventing the development of elevated cholesterol levels or reducing elevated cholesterol. For the same reason, FDA considers the product names "**PhytoPharmica Clinical Nutrients to Retain Healthy Cholesterol Levels**" and "**Enzymatic Therapy Doctor's Choice to Retain Healthy Cholesterol Levels**" to be implied disease claims in and of themselves.

The products **Enzymatic Therapy, Inc. DMG-B15-Plus** and **PhytoPharmica Pro-DMG-B15** use the claims "Potassium is well-known for the role it plays in regulating blood pressure...role it plays in blood pressure" and "Researchers continue to explore the connection between calcium and cholesterol levels." In the preamble to the January 6, 2000 final rule on structure/function claims (see 65 FR 1000 at 1018), FDA stated that claims about the maintenance of normal cholesterol levels did not necessarily constitute implied disease claims. We stated, however, that because "many people think of cholesterol solely in terms of the negative role of elevated cholesterol in heart disease," in order to avoid implying that the product prevents or treats heart disease, a cholesterol maintenance claim would have to clarify that the product is only for maintenance of cholesterol levels that are already within the normal range. The claim for your product

contains no such clarification, however. Therefore, FDA considers it to be an implied claim to prevent coronary heart disease by preventing the development of elevated cholesterol levels or reducing elevated cholesterol. The same principle applies to your claim about blood pressure; that is, a claim that does not establish that the claim is about blood pressure that is already within normal limits implies that the product is intended to treat elevated blood pressure or hypertension, which is a disease.

The products **Enzymatic Therapy Garlinase 4000** and **PhytoPharmica Garlitrin 4000** use the claims "...retain healthy cholesterol levels" and "Support retention of healthy cholesterol levels." In the preamble to the January 6, 2000 final rule on structure/function claims (see 65 FR 1000 at 1018), FDA stated that claims about the maintenance of normal cholesterol levels did not necessarily constitute implied disease claims. We stated, however, that because "many people think of cholesterol solely in terms of the negative role of elevated cholesterol in heart disease," in order to avoid implying that the product prevents or treats heart disease, a cholesterol maintenance claim would have to clarify that the product is only for maintenance of cholesterol levels that are already within the normal range. The claim for your product contains no such clarification, however. Therefore, FDA considers it to be an implied claim to prevent coronary heart disease by preventing the development of elevated cholesterol levels or reducing elevated cholesterol.

The product **PhytoPharmica Glucoril** uses the claim "...an herb long recommended for diabetics." This is a disease claim because it implies that, because the product is intended for use by people with diabetes, it is intended to treat the disease that these patients have and which distinguishes them from the general consumer population.

The products **Enzymatic Therapy St. John's Wort Extract** and **PhytoPharmica HyperiMed** use the claims "...relieving occasional anxiety, apathy, sleeplessness, and feelings of worthlessness." The claims describe a group of signs and symptoms that, when considered together imply that the product is intended to treat, prevent, or mitigate diseases, namely, anxiety disorders and depression.

The products **Enzymatic Therapy Olive Leaf Extract with Hawthorn** and **PhytoPharmica Olive Leaf Extract with Hawthorn** use the claim "Useful in dilating coronary blood vessels and increasing blood flow to the heart." A claim about a product affecting blood flow to the heart is an implied disease claim. While blood flow is a normal function of the body, a claim about external intervention to affect coronary blood flow is implicitly a claim to correct a defect in coronary blood circulation because it is not necessary to improve, modify, or otherwise affect coronary blood flow unless it is impaired. Therefore, the claim for this product is a disease claim because it is a claim to treat coronary heart disease and other coronary vascular disorders.

The products **Enzymatic Therapy Potassium Plus** and **PhytoPharmica Potassium Plus** use the claims "Supports retention of healthy blood pressure levels," "...benefits blood pressure," and "...helps regulate blood pressure." As discussed above, a claim about blood pressure benefit that does not make clear that the product is only for people with blood pressure that is already within normal limits implies that a product is intended to treat elevated blood pressure or hypertension, which is a disease. The claims for these products are, therefore, disease claims.

The product **Enzymatic Therapy Quercezyme-Plus** uses the claim "...support enzyme functions that break down fibrin, a blood-clotting agent." In the preamble to the January 6, 2000 final rule on structure/function claims, we stated that although platelet aggregation is a normal function needed to maintain homeostasis, inhibiting or decreasing platelet aggregation is a well-recognized therapy for the prevention of stroke and recurrent heart attack (65 FR 1016). External intervention to affect platelet aggregation and other aspects of blood clotting is not necessary except in conditions where an underlying disease calls for intervention. In fact, absent a need to alter platelet aggregation or blood clotting ability, intervention to increase or decrease the ability of blood to clot may result in untoward effects, such as increased clotting or bleeding. Consequently, any claim that a product affects platelet aggregation or other aspects of blood clotting implies that the product is intended to correct some deviation in platelet function from the normal. Therefore, the claim you are making for this product is a disease because it is a claim to treat diseases or disorders associated with clot formation such as heart attack and stroke.

21 U.S.C. 343(r)(6) makes clear that a statement included in labeling under the authority of that section may not claim to diagnose, mitigate, treat, cure, or prevent a specific disease or class of diseases. The statements that you are making for these products suggest that they are intended to treat, prevent, or mitigate diseases. These claims do not meet the requirements of 21 U.S.C. 343(r)(6). These claims suggest that these products are intended for use as drugs within the meaning of 21 U.S.C. 321(g)(1)(B), and that they are subject to regulation under the drug provisions of the Act.
