SUMMARY OF INSPECTION

This comprehensive surveillance inspection of egg producers and packers was conducted per the CHI-DO work plan FY11 according to the Egg Farm for Monitoring Compliance with Egg Safety Rule Assignment #1111-04 ORA Concurrence #2011012601, FACTS # 1258067. 21 CFR 115 and 118 were used to review the firm's compliance with the egg rule implemented in July 2010.

On March 25, 2011 I, Pablo Alcantara, Investigator, Tara M. Carolfi, Investigator, and Dariusz Galezowski, Investigator, arrived at Brown Produce Co. located at Rt. 37 South Farina, IL 62838. At this time we presented our credentials and issued a FDA 482, Notice of Inspection, to Mr. Roger L. Sager, Vice-President/Owner, and most responsible person. Mr. Roger L. Sager stated that Mr. Larry L. Pemberton, co-owner, is a more knowledgeable person regarding the operations at the firm. At this time Mr. Larry L. Pemberton informed us that Brown Produce Co. is a breaker only facility, and they do not own any laying hens. Due to the fact that this firm does not own any laying hens, this facility falls under USDA jurisdiction.

The firm receives most of its eggs from (b) (4) located at (b) (4), (b) (4). The firm also receives eggs from (b) (4), (b) (4) located at (b) (4) (b) (4) (Exhibit 1). Mr. Larry L. Pemberton provided us an affidavit stating that the firm was a breaker only facility. No samples were collected during this inspection.
