OBSERVATION 1

Failure to achieve satisfactory rodent control within a poultry house.

Specifically, we observed rodent activity in the caged area and the manure pit in your poultry house.

On 03/28/2011 we observed the following:

- a) At least 13 live rodents running among the rows in the manure pit.
- b) Rodent burrows throughout each row of manure in the manure pit.

On 03/29/2011 we observed the following:

- a) Rodents in **b4** in the caged area of the poultry house.
- b) One live rodent in the walkway between rows **b4** one live rodent in the walkway between rows **b4** and one live rodent in the walkway between rows **b4**
- c) One live rodent on the **b4** at the front of row **b4** and one live rodent on the **b4** at the front of row **b4**
