

**Chlortetracycline Beef Cattle Feed – AUREO^a – BE/BP – Top Dress
Type C Medicated Top Dress Feed
(chlortetracycline Type C top-dress medicated feed)**

Caution: Federal law restricts medicated feed containing this veterinary feed directive (VFD) drug to use by or on the order of a licensed veterinarian.

For calves, beef and non-lactating dairy cattle: Treatment of bacterial enteritis caused by *Escherichia coli* and bacterial pneumonia caused by *Pasteurella multocida* organisms susceptible to chlortetracycline.

Feed for not more than 5 days to provide chlortetracycline at the rate of 10 mg per pound of body weight per day. ____** pounds of this cattle feed will medicate 100 lbs of body weight. Administer as a top dress or mixed into the daily ration. If top-dressed, spread uniformly on top of ration and allow sufficient space so that all cattle can eat at the same time.

A withdrawal period has not been established for this product in pre-ruminating calves.
Do not use in calves to be processed for veal.
