Active Ingredient: Gentamicin sulfate

Dosage Form; Route: Ointment; topical

Recommended Studies: Acceptable comparative physicochemical characterization of the test and reference standard (RS) formulations of the product to establish that the test product is pharmaceutically equivalent¹ to the RS (Gentamicin sulfate topical ointment, EQ 0.1% base) with identical strength.

Analytes to measure (in appropriate biological fluid): Not Applicable
