The **U.S. Food and Drug Administration Office of Women's Health** (FDA OWH) invites you to collaborate with them on the **College Women's Campaign**. The goal of the campaign is to disseminate FDA health and safety information to college students and staff through collaborations with college health centers, health education programs, health professional schools, and other campus programs.

The FDA Office of Women's Health provides schools with free FDA fact sheets, posters and social media messages to teach their campus community about health and safety. Participating schools can also receive a literature display stand at no cost. To date, over 200 schools are participating in the College Women's Campaign.
