1/The Operating Plan reflects a previously notified transfer in FY 2017 of \$3.575 million from the Human Drugs Program to the Office of Medical Products and Tobacco within Headquarters.

2/The Medical Device Postmarket Safety amount reflects an increase above surveillance activities FDA already carries out using base resources.

3/The Omnibus provides \$170 million in budget authority for GSA Rent. This reflects a reduction of \$6.5 million relative to FY 2016 Enacted level of \$177 million.

\*The FY 2017 Omnibus provides FDA the authority to collect fees under the Medical Countermeasure Priority Review Voucher program. FDA continues to develop estimates for the fee levels anticipated to be collected in FY 2017.

\*\*The FY 2017 total for the National Integrated Food Safety System and Import Safety reflect the total amount of increases provided by Congress in FY 2016 and FY 2017 for these activities. The allocation of the FY 2017 totals may change as final grant, cooperative agreement, and contract awards are determined, and other administrative actions are determined. The FY 2016 Final Column reflects totals for National Integrated Food Safety System and Import Safety different than originally planned due to the timing of receiving the additional resources and being able to bring staff onboard.
