

# First Warning Letters Issued for Illegal Underage Sales of E-Cigarettes, E-Liquids, and Cigars

We recently issued the first warning letters to 55 tobacco retailers—including major national retail chains, tobacco specialty stores, and online retailers—for selling newly-regulated tobacco products, such as e-cigarettes, e-liquids, and cigars, to minors.
