

**Chlortetracycline-Pennchlor/Salinomycin Broiler
Feed Type C Medicated Complete Feed
(chlortetracycline/salinomycin Type C medicated feed)**

Caution: Federal law restricts medicated feed containing this veterinary feed directive (VFD) drug to use by or on the order of a licensed veterinarian.

For the prevention of coccidiosis caused by *Eimeria acervulina*, *E. tenella*, *E. brunetti*, *E. maxima*, *E. necatrix* and *E. mivati* and as an aid in the reduction of mortality due to *E. coli* infections susceptible to chlortetracycline.
