



Produce Safety Network

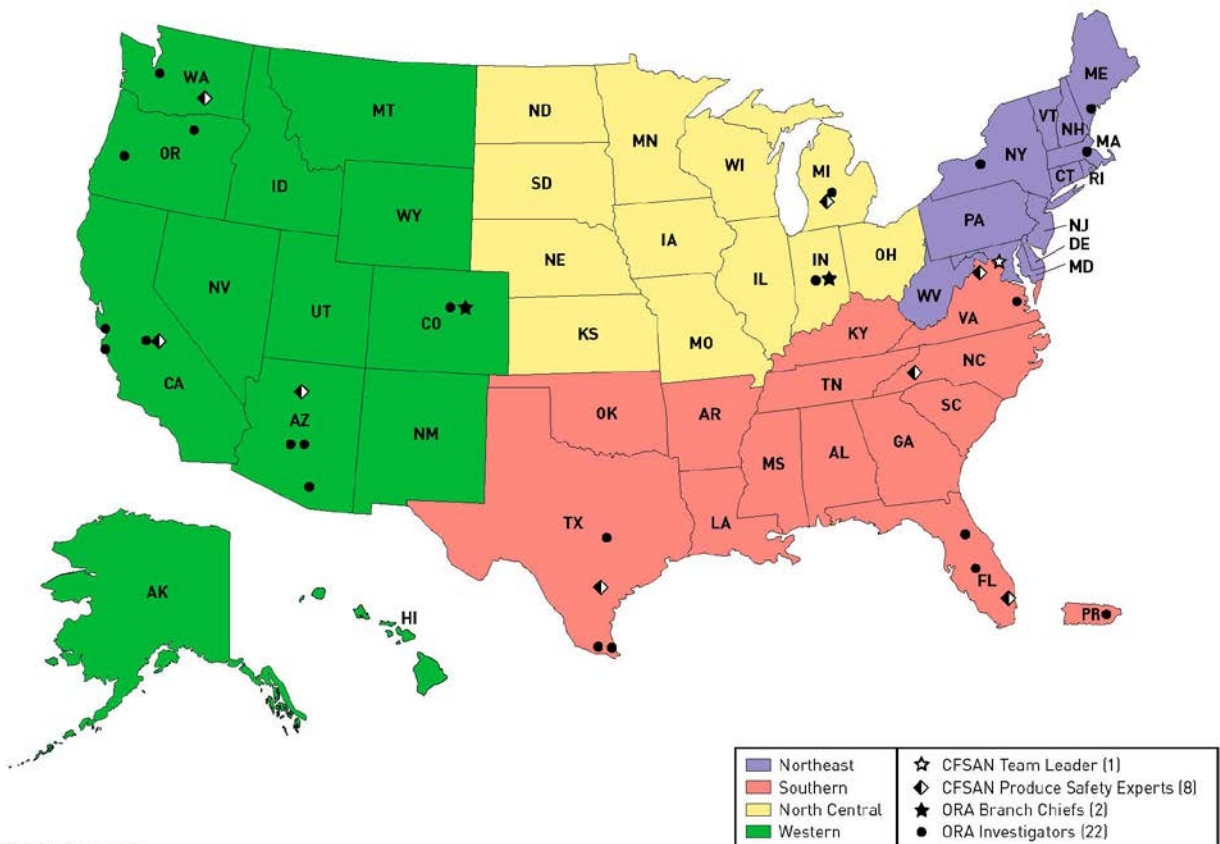
Implementation of the Produce Safety Rule provides unique opportunities and challenges, including recognition of regional differences in growing practices, and increased reliance on state regulatory partners.

To achieve the goal of high rates of industry compliance, FDA created the Produce Safety Network (PSN). The PSN, comprised of both ORA and CFSAN staff, is regionally-based and responsible for collaborating and communicating with regional partners to build on existing programs to achieve high levels of compliance in the farming community.

Locating PSN staff in specific growing regions allows those staff members to develop expertise in the growing conditions and practices in their regions, which in turn enhances their ability to provide outreach and technical assistance that is specifically tailored to the unique needs of their regions.
