Availability of Pantoprazole Sodium for Injection, 40 mg

Dear Healthcare Professional:

The purpose of this letter is to inform you of efforts to avoid a drug shortage for Pantoprazole Sodium for Injection, a proton pump inhibitor used to block the production of acid by the stomach. In coordination with the U.S. Food and Drug Administration (FDA), AuroMedics Pharma will be distributing Pantoprazole Sodium for Injection manufactured by Aurobindo Pharma Ltd. utilizing an additional packaging line and lyophilization equipment not yet approved by the FDA. AuroMedics Pharma LLC is the U.S. generic injectables subsidiary of Aurobindo Pharma Ltd., and distributes Aurobindo Pharma's injectable drug products in the U.S.

Pantoprazole Sodium for Injection manufactured by Aurobindo Pharma Ltd. from the unapproved packaging line and lyophilization equipment will be traceable by lot number maintained on file at the manufacturing site. The product is acceptable from the pharmaceutical quality standpoint.
