Dear Tribal Leader:

The U.S. Food and Drug Administration (FDA), through its Center for Tobacco Products (CTP), regulates the manufacturing, marketing, and distribution of all tobacco products, including cigarettes, smokeless tobacco, e-cigarettes and cigars. CTP conducts inspections, also called compliance checks, of tobacco retailers throughout the United States and U.S. territories to determine retailer compliance with federal tobacco laws and regulations, including the prohibition on selling tobacco products to individuals under the age of 18.

FDA contracts with states, territories, and Tribes to conduct compliance checks of tobacco retailers, information about compliance check inspections can be found here:

I am writing to let you know that the FDA has published a Request for Proposal (RFP) to contract with American Indian and Alaska Native (AI/AN) Tribes to conduct compliance check inspections of tobacco product retailers on tribal lands to help ensure retailer compliance with federal tobacco laws and regulations. Please note that FDA does **not** regulate the use of traditional (ceremonial) tobacco. The FDA understands and respects the use of traditional tobacco by Native tribes.

Tobacco retailers play an important role in protecting children and adolescents from the deadly effects of tobacco use by complying with the law prohibiting the sale of tobacco products to minors. Unfortunately, the most commonly observed violations are sales of tobacco products to minors. It is important that FDA continue to protect kids by ensuring retailers comply with the law. According to the Centers for Disease Control and Prevention (CDC), the AI/AN population has the highest prevalence of cigarette smoking compared to any other population group in the United States and AI/AN high school students have the highest rate of e-cigarette use, compared to all other high school students. We appreciate that many tribal governments have been working actively to reduce tobacco use within their tribes and to prevent smoking and other tobacco use among tribal youth. An FDA collaborative partnership with tribes to reduce youth access to tobacco products will help protect the health of Native communities by helping to ensure compliance with the Tobacco Control Act.


