In response to email below from Dr. Rodgers and voice message on the same date, Dr. Ross spoke with Dr. Kenimer. A CR letter has been signed for the supplement. Therefore, there is no rush to submit the revised package insert. The CR letter contains more items than just a request for revised labeling; items that have been discussed with Dr. Kenimer many times previous in connection with supplements 5019 and 5027 (for example, lots in support). In addition, it would be an unusual course of business to alert the Agency on the due date for a supplement that additional materials for review were coming that may necessitate the rewriting and sign-off of a CR or approval letter. Dr. Kenimer would communicate the information to Dr. Rodgers, as Dr. Rodgers has not been listed as a representative on the file and the Agency is unfamiliar with her involvement in the file.
