The purpose of this letter is to notify the California State Board of Pharmacy (BOP) that the U.S. Food and Drug Administration (FDA) does not intend to take further action with regard to an inspection of a pharmacy licensed by the California BOP, BBS Pharmacy, Inc. (formerly Pacific Healthcare, Inc.) dba B&B Pharmacy, located at 10244 Rosecrans Avenue, Bellflower, CA 90706-2602 (retail pharmacy license name under B&B Pharmacy #54170, expires April 1, 2018).

FDA inspected the firm from May 1, 2017, to May 11, 2017. The California BOP was informed of the inspection but did not accompany FDA investigators during the inspection. No Form FDA 483 was issued to the firm.

During the inspection, the FDA investigators reviewed a small sample of records for products compounded by BBS Pharmacy, Inc. dba B&B Pharmacy and determined, based on this sample, that this firm appears to obtain valid prescriptions for individually-identified patients for the drug products that it compounds and distributes.

FDA does not intend to take further action with regard to the findings of this inspection. Please notify us if you become aware of any adverse events or product quality concerns associated with drugs made at this facility, or if you observe any practices at this facility that concern you or that could be violations of Federal law.
