Pfizer Injectables is committed to providing information on supply so that appropriate plans can be made to facilitate patient care and safety. We want to provide updated information on the supply status of the prefilled syringes containing Penicillin.

BICILLIN L-A

Pfizer's supply of Bicillin L-A continues to improve. The September deliveries have been received and we have increased allocations for select presentations below. We plan to keep an allocation in place until the anticipated complete recovery in 4Q 2017. Please see updates to the table below in red. We continue to recommend consideration of prioritizing where BICILLIN L-A is the only choice for the patient's treatment. Please consider alternative drugs where clinically applicable.
