

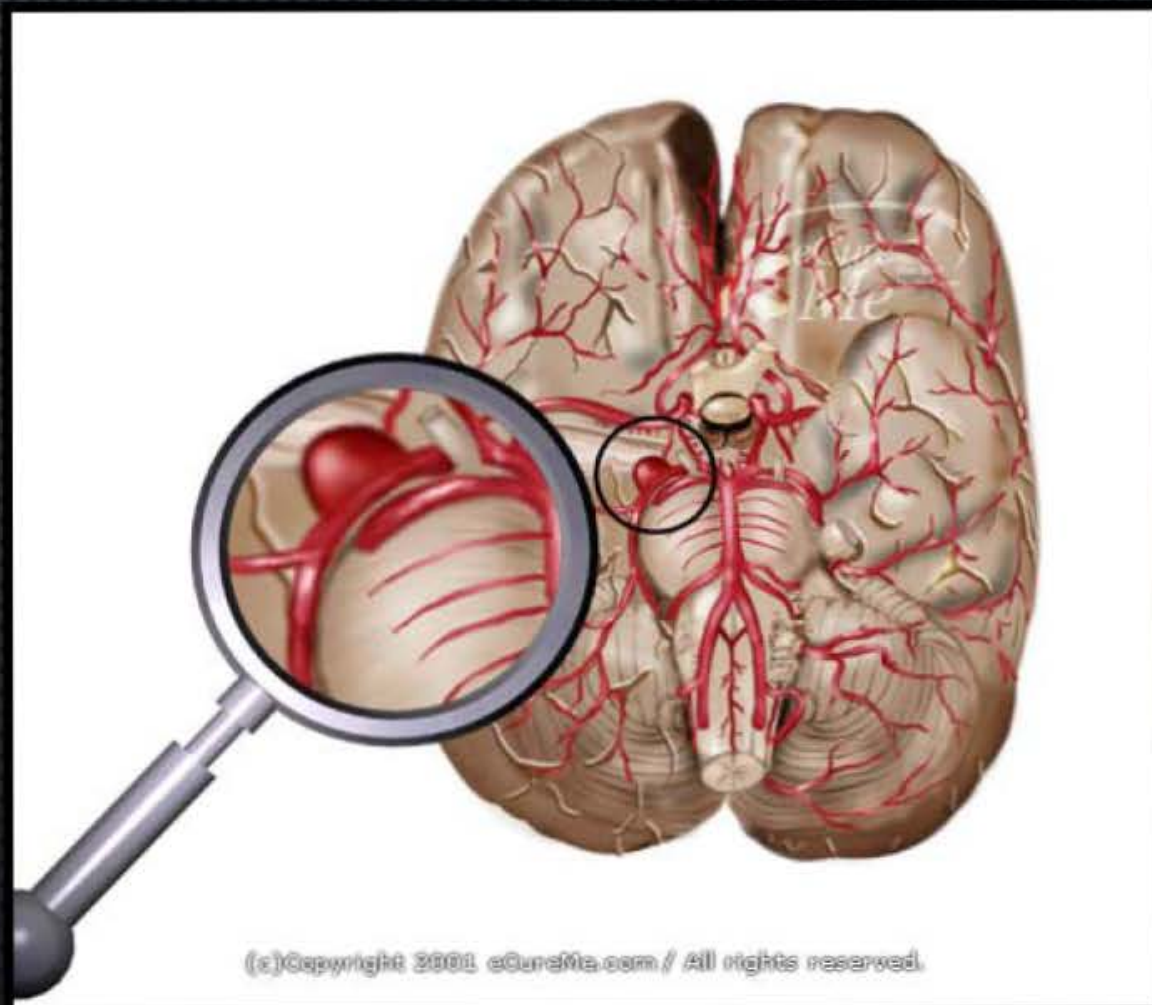

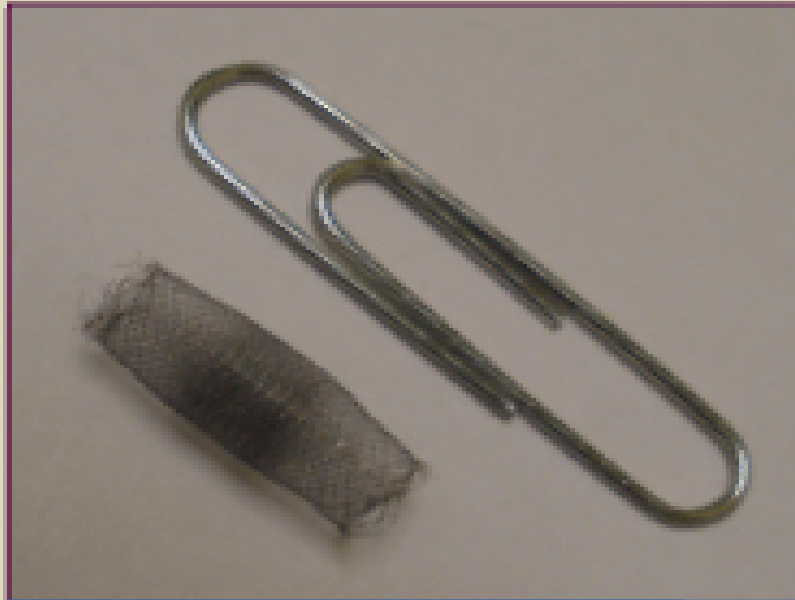
Stroke Awareness

Do YOU know the signs?

- Sudden numbness or weakness - especially to only one side of the body
- Sudden confusion, trouble speaking or understanding
- Sudden trouble seeing in one or both eyes
- Sudden dizziness, trouble walking, loss of balance or coordination
- Sudden severe headache with no known cause

If you, or someone you love, experiences ANY of these symptoms
Call 911 immediately and tell the dispatcher it is a suspected stroke!
Response time is critical! Time lost is brain lost!

It is composed of platinum ,tungsten, cobalt ,chromium and nickel alloys making it MRI compatible.

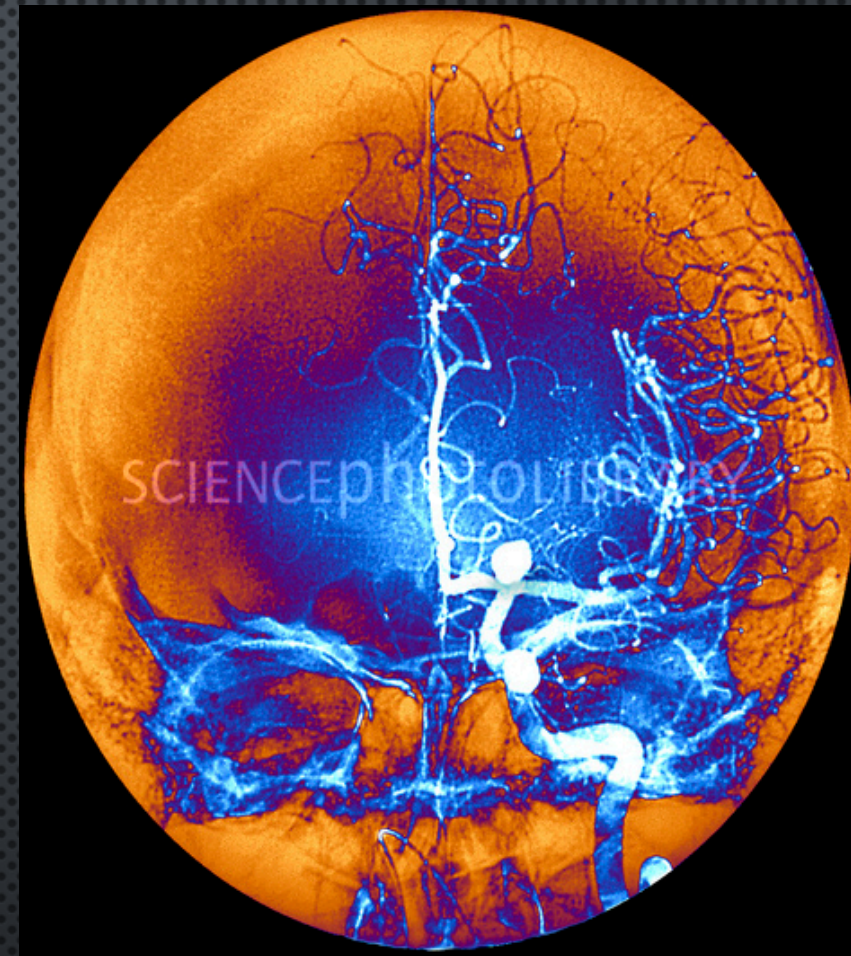

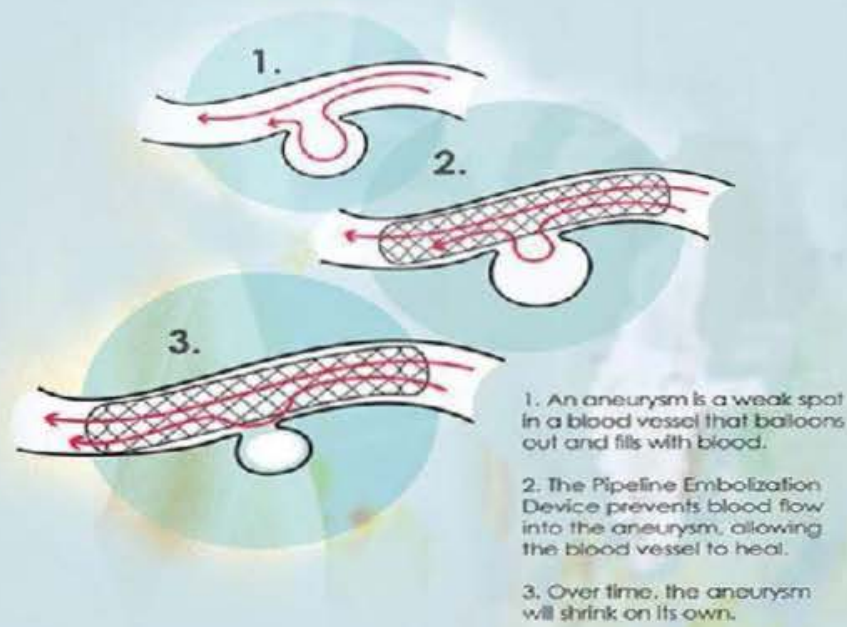

AN ANGIOGRAM OF LEFT ICA ANEURYSM.

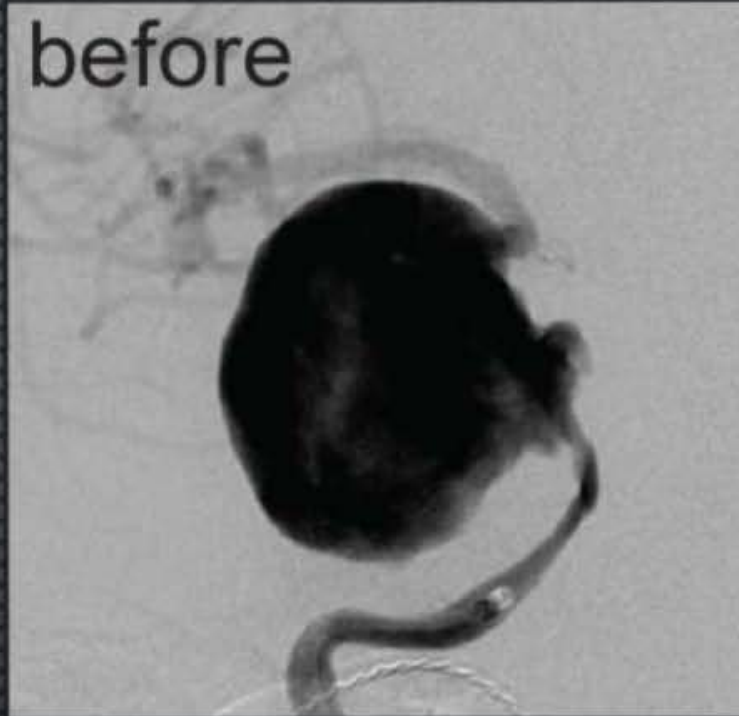
