TOBACCO PRODUCT LISTING UPDATES



1. If you have not made changes to the information you previously submitted with your tobacco product listings, you do not have resubmit that information.
2. You must submit updates to your tobacco product listings only if you have made certain changes to those listings or introduced additional tobacco products into commercial distribution.

TOBACCO PRODUCT LISTING UPDATES



Report These Updates to FDA:

- You have introduced a tobacco product into commercial distribution and you did not include that product in a previous submission, or
- You discontinued manufacturing a tobacco product for commercial distribution since your last listing, or
- You listed a tobacco product as discontinued in a previous listing, but you have since resumed manufacturing that tobacco product for commercial distribution, or
- You have made any material change to any information you previously submitted.

TOBACCO PRODUCT LISTING UPDATES



Report These Updates to FDA:

- You have introduced a tobacco product into commercial distribution and you did not include that product in a previous submission, or
- You discontinued manufacturing a tobacco product for commercial distribution since your last listing, or
- You listed a tobacco product as discontinued in a previous listing, but you have since resumed manufacturing that tobacco product for commercial distribution, or
- You have made any material change to any information you previously submitted.

- Example: Manufacturer has changed its deemed tobacco product's label to include the nicotine addictiveness warning statement:

WARNING: This product contains nicotine. Nicotine is an addictive chemical.

- The requirement to include the addictiveness warning statement to product packages and advertisements applies to cigarette tobacco, roll-your-own tobacco, and covered tobacco products (other than cigars and those covered tobacco products that do not contain nicotine).
- Manufacturers cannot manufacture such products with non-compliant packages beginning August 10, 2018, and cannot distribute such products beginning September 11, 2018, irrespective of the date of manufacture.
