On June 22, 2009, the President signed into law the Family Smoking Prevention and Tobacco Control Act (the Tobacco Control Act) (Public Law 111-31). The Tobacco Control Act granted FDA important new authority to regulate the manufacturing, marketing, and distribution of tobacco products to protect the public health generally and to reduce tobacco use by minors. To carry out this responsibility, FDA established the Center for Tobacco Products (CTP).

The incumbent serves as a Supervisory Consumer Safety Officer (Branch Chief) in the Office of Compliance and Enforcement's Quality Assurance and Improvement Branch and directs a staff responsible for providing technical and other nonfinancial assistance to small tobacco product manufacturers, providing support for the development of information business processes and the management of the CTP human subject protection audit program.

#### Major Duties:

- Oversee the Office of Small Business in OCE
- Supervise a team of compliance and regulatory staff in support of information technology development
- Supervise the conduct, review, communication, and closeout of audits of agency-sponsored, -funded, or -conducted studies involving human subjects
- Develops and implements policies and plans, makes critical decisions and provides expert advice concerning approaches and options that are sound and feasible to achieve organizational goals and objectives.

- Plans, and schedules work to be accomplished by staff, sets and adjusts priorities and prepares schedules for the completion of work

Desired Knowledge and Skills:

- Ability to advise others in the application of Agency rules, regulations, and procedures.
- Skill in identifying problems, gathering information, drawing conclusions, recommending solutions, preparing reports, negotiating acceptance, and implementing recommendations.
- Solid foundation in regulatory review work.
- Excellent oral and written communication skills.
