99.74% (only one *State without state-level agency enrolled*) of the U.S. population that reside in a state in which one or more of the eligible state-level agencies with a retail food regulatory program has enrolled in the Voluntary National Retail Food Regulatory Program Standards.

69.09% of the U. S. population that reside in a locality (city, county, parish, etc.) in which the eligible local-level agency with a retail food regulatory program has enrolled in the Voluntary National Retail Food Regulatory Program Standards*.
