Emergency Syringe Portfolio Update

Dear Valued Customer,

While Pfizer Hospital continues to prioritize manufacturing enhancements, we are informing you of additional near-term delivery projection updates in our emergency syringe portfolio to help keep you informed as you plan patient care.

The next delivery and recovery projections of some of our Ansyrr Emergency Syringes and Abboject Emergency Syringes have shifted due to manufacturing line reviews and equipment installation. At the same time, we also have been able to deliver certain Ansyrr Emergency Syringes and Abboject Emergency Syringes earlier than projected. Additionally, we have seven (7) products in which deliveries are expected this month.

A detailed list of the impacted emergency syringe products is found in the attached document dated 11/20/2019. Please review the attached list for details on status, including updated next delivery and recovery estimates. As we return to market across the Abboject and Ansyrr product lines, certain products have been prioritized based on medical need. Pfizer is making every effort to restock the market and provide product as quickly as possible.
