**Part 1 – Description**

The U.S. Food and Drug Administration’s (FDA) Center for Food Safety and Applied Nutrition (CFSAN) is requesting KeyAcid Rhodamine WT Liquid Dye. This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulation (FAR) Part 12.603. This announcement constitutes the only solicitation; quotes are being requested, and a separate written solicitation will not be issued.

This solicitation is a Request for Quote (RFQ) using FAR Parts 12 and 13 procedures. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2020-05 March 30, 2020. The North American Industry Classification System (NAICS) code for the proposed acquisition is 325998, All other Miscellaneous Chemical Product and Preparation Manufacturing, Small Size Standard 1,000 Employees.

### **Part 3 – Description/Specifications**

#### **3.1 Background**

The Statutory provisions of the Federal Food, Drug, and Cosmetic Act as amended by the Food and Drug Administration Modernization Act (FDAMA), Section 406), Title 21 Code of Federal Regulations, Section 310.305, and Title 21 Code of Federal Regulations, Section 314.80 require FDA to ensure the safety and effectiveness of regulated marketed products.

The Office of Food Safety-Division of Seafood Safety's Shellfish and Aquaculture Policy Branch (SAPB) ensures the safety and effectiveness of uncooked shellfish as part of FDA's National Shellfish Sanitation Program (NSSP). As part of its charge under the NSSP, SAPB provides technical assistance to states, including the application of dye modeling work to assist in classifying shellfish growing areas located near pollution sources, such as wastewater treatment plants or sewage collection systems, used to simulate the dispersion and dilution of pollutants released into the growing area. In addition, SAPB also serves a critical role of providing Subject Matter Expertise on ORA shellfish program audits of the growing area which includes evaluating computer models used to determine shellfish closure zones around wastewater treatment plant discharges in proximity to shellfish growing areas

#### **3.2 Objective**

The SAPB is seeking to purchase 280 pounds of KEYACID Rhodamine WT Liquid dye to be used in simulating pollutant dilution and dispersion in tidal estuaries that can be used for both providing technical assistance as well as evaluating established shellfish closure zones as part of an FDA audit of state or foreign shellfish programs.

#### **3.3 Requirements**

To supply 280 pounds of KeyAcid Rhodamine WT Liquid dye (to be delivered in 7 x 40 pound (5 gallon) units).

Characteristics of the Keyacid Rhodamine WT dye are as follows:

Appearance: Clear, very dark red aqueous solution

Specific Gravity: approximately 1.15 @ 20 deg C

pH: 10.8 +/- 0.7 @ 2 deg C

Dispersion in sea water; Shows complete dispersion when dropped into seawater

Bleachability: Bleachable with sodium hypochlorite  
pH sensitivity: No significant change in fluorescence between 5.5 and 11.0  
Freezing point: Approx. -10 deg C  
Viscosity: Less than 25 centipoises @ 25 deg C.

The Rhodamine WT dye is be capable of estimating the changes in pollutant concentration and dilution over time and thus be capable of simulating these changes under varying conditions including changes in tidal direction, velocity, water depth, wind speed and direction, as well as changes in pollutant flow rate and concentration.

The dye is a necessary commodity to estimate the level of pollutants entering shellfish growing areas from nearby pollutions sources and help determine the influence of these pollutants. This is very important information in helping states and foreign shellfish programs classify shellfish growing areas to ensure the safety of shellfish. The dye studies also are instrumental in calibrating computer models, which are used for extended applications, such as assisting with outbreak investigations or evaluating other pollutant discharge events such as an oil spill or radioactive release of materials.
