**Part 1 – Description**

The U.S. Food and Drug Administration’s (FDA) Center for Food and Safety and Applied Nutrition (CFSAN) is requesting “Microplate Reader” for absorbance and fluorescence-based protein quantitation and absorbance, fluorescence and luminescence-based ELISAs. This is a solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulation (FAR) Part 12.603. This announcement constitutes the only solicitation; quotes are being requested, and a separate written solicitation will not be issued.

This solicitation is a Request for Quote (RFQ) using FAR Parts 12 and 13 procedures. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2020-07 July 02, 2020. The North American Industry Classification System (NAICS) code for the proposed acquisition is 334516 Analytical Laboratory Instrument Manufacturing, Small Size Standard 1,000 Employees.

### **Part 3 – Description/Specifications**

#### **3.1 Background**

The Chemical Contaminants Branch within the Office of Regulatory Science, Division of Bioanalytical Chemistry requires the purchase of a plate reader to assist in protein -based allergen detection methods. The requested plate reader will provide the necessary requirements that are critical for the quantitation of protein allergens in foods and assist in allergen detection method development and validation. It can also assist in absorbance and fluorescence-based DNA/RNA quantification and purity check for DNA based allergen- detection methods. The proposed equipment is required to continue and expand the efforts of the US FDA to protect the US food supply and respond to emergencies in a timely manner.

#### **3.2 Objective**

The purchase of an imaging system is critical to support the Agency's mission in the development and validation of quantitative analytical methods for research and regulatory use.

The major components of the acquisition plan are as follows:

- Entire system must be warranted for parts and labor for 1 year from date of installation.
- The system must be newly manufactured unit, not used or refurbished, or previously used for demonstration. The instrument must meet all the technical specifications specified below.

2. Quad4 Monochromators system (2 excitation and 2 emission monochromators).
3. Fluorescence intensity Ex 230 – 850 nm, Em 280 – 850 nm.
4. Absorbance 230 – 1000 nm.
5. Detectors: Fluorescence – PMT, UV and red-sensitive, absorbance-UV silicon photodiode, luminescence-photon counting system with low dark current PMT.
6. Capable of performing spectral scanning.
7. Capable of automated z-focusing and fluorescence scanning.
8. Can read 6- to 384-well plates.
9. Temperature control of Ambient +5 °C up to 42 °C.
10. Both linear and orbital shaking capabilities.
11. Fastest reading capability e.g. less than 30 sec for 96 well plates.

## **Part 4 –Performance and Deliverables**

### **4.1 Delivery**

The vendor is responsible for delivery of the instrument and all components specified above. The vendor will demonstrate upon installation that the item will meet all performance specifications by the manufacturer. The entire system must ship as one lot, no back orders allowed. If shipments must be sent separately, payment will not be made until all deliveries have been made. The instrument will not be accepted until those performance specifications have been met. The project officer will perform inspection and acceptance of the Microplate Reader by Tecan or Equal. The entire system will be warranted for parts and labor for twelve (12) months from date of installation. Service and installation must be provided by service engineers who are trained and certified by the original manufacturer of the instrument. Engineers should have access to the manufacturer's latest technical developments, repair procedures, application updates, diagnostic
