This is to notify you that your request to update the Instructions for Use (IFU) of the SARS-COV-2 R-GENE to; (1) include the results of a post authorization clinical evaluation study conducted to fulfill Condition of Authorization S. in the letter authorizing the emergency use of the SARS-COV-2 R-GENE, issued on May 6, 2020, and (2) include the results from testing the FDA Reference Panel that were reviewed and acknowledged under EUA200445/S002, is granted. Upon review, we concur that the data and information submitted in EUA200445/S001 supports the requested updates to the authorized labeling for the SARS-COV-2 R-GENE.
