#### 17. Clinical Service Contributions:

**Clinical Expertise:** I am a senior MFM clinician with 3 decades of clinical experience in managing pregnancies at increased risk of adverse outcomes especially pregnancies with co-morbidities of substance abuse, diabetes, hypertension and HIV infection.

**Chief of Service:** As the Chief of the Emory Obstetrics and Gynecology Service at Grady Memorial Hospital (GMH) I have played an instrumental role in helping the hospital achieve its goal of becoming the top academic public hospital in the United States. Key initiatives that I have had significant input includes:

- March Of Dimes sponsored 39 week initiative to reduce the incidence of elective preterm delivery.
- Designation of GMH as a Baby Friendly Hospital (4th such

designation in Georgia).

- Planning of \$ 36 million dollar renovation of GMH labor and delivery, perinatal center and prenatal clinics.
- Support of hospital wide quality initiatives which moved hospital from UHC 4<sup>th</sup> quartile to 1<sup>st</sup> quartile among public academic health systems.
- Our clinical service line has consistently met service goals resulting in bonuses to physician staff.
- Member of Grady Hospital Obstetrics Gynecology Quality Council
- Medical lead for postpartum hemorrhage Quality Team
- Clinical lead of the Grady Regional Perinatal Center which accepts high risk maternal transfers from throughout north Georgia (one of six regional perinatal centers in Georgia).

**HIV Infection:** My clinical research in HIV infection in pregnancy was instrumental in establishing that routine voluntary HIV antibody testing in pregnancy was superior to risk factor-based screening. We found that routine voluntary HIV antibody screening identified twice as many infected parturients as risk based screening. Routine voluntary screening allowed us to characterize the seroprevalence of HIV infection in an inner-city prenatal population. Our studies were among the initial HIV seroprevalence studies in pregnancy to be published in the United States. As a direct results of our studies. Routine voluntary HIV screening in pregnancy became the standard of care. Implementation of this screening methodology facilitated the identification of cohorts of HIV infected and uninfected parturients. These cohorts were used to describe pregnancy outcomes in these populations. With the advent of new therapies we have continue to chronicle HIV infection among women of reproductive age , including application of rapid HIV testing on obstetrical units, examining the use of HAART on contraceptive practice and characterizing the risk of mother to child transmission among mothers congenitally infected with HIV.

**Maternal Mortality:** In 2010 Amnesty International published a document entitled "Deadly Delivery" which Identified Georgia as the state with the highest maternal mortality in the United States. To address this public health crisis. I organized a series of planning meetings with key stakeholders from the Georgia Department of Public Health Georgia Obstetrical and Gynecology Society and CDC to discuss strategies to address this crisis. This collaboration lead to the reinstitution of formal

maternal mortality review, and the formation of a 30 member multidisciplinary maternal mortality review committee which I serve as co-chairman. The committee reviews all maternal deaths in the state. In 2012-2014 the committee reviewed 250 maternal deaths, 25(30%) of which were pregnancy related and (70%) which were pregnancy associated. We anticipate that maternal mortality review will identify factors that will lead to prevention strategies that will make child birth in Georgia safer.
