## Introduction

The Food and Drug Administration (FDA or Agency) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices are safe, and effective.

The Center for Drug Evaluation and Research (CDER) is responsible for regulating prescription drugs, including new drugs, generic drugs, biological products and biosimilars as well as over-the-counter drugs (OTC). CDER's drug regulatory responsibilities include premarket review of

new drugs and generic drugs; maintenance of the OTC drug monograph system; monitoring of all marketed drug safety and promotion activities; review, monitoring, and enforcement of drug quality during the entire drug life cycle; and ensuring drug products in the market comply with the law.

The Office of Pharmaceutical Quality (OPQ) oversees and coordinates the overall regulation of human pharmaceutical quality within CDER, including submission review, manufacturing facility assessment, and surveillance of the quality of marketed pharmaceutical products.

The Office of Program and Regulatory Operations (OPRO) is accountable for leading and coordinating regulatory review processes, facilitating a quality management system, and maintaining a learning and professional development program in collaboration with review offices within the OPQ. Specifically, the Division of Organizational Excellence and Learning & Professional Development (DOELPD) is responsible for overseeing the quality management system (QMS) for OPQ.

### Duties/Responsibilities

- Provides leadership, review, and oversight for Division programs for the planning, focusing, and coordinating of Branch activities.
- Directs the coordination with all OPQ offices to identify training, development, and certification needs and requirements for all job functions in OPQ.
- Oversees the development and approves the implementation of the QMS and/or other established guidelines for the CDER Quality Management Program (QMP) for OPQ.
- Applies quality control systems and quality assurance methods to determine risks and compliance standards for work and implements associated risk mitigation actions.
- Manages OPQ's internal management review process and develops quality metrics for OPQ work products, processes, and services.
- Oversees the development, implementation, and maintenance of the auditing Corrective and Prevent Actions (CAPA) programs.

Supervisory Responsibilities: Manages a functional discipline. Supervise and evaluate staff of branch chiefs who serve as experts in their field. Provides leadership and management oversight to subordinate staff. Supervises and evaluates staff of branch chiefs who serve as experts in their field. Provides occupational specific technical and administrative direction and supervision 25 percent or more of the time to subordinate staff performing the work and functions of the organizational unit. Obtains and identifies strategic objectives for their organization.

### Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.

- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.
- Males born after December 31, 1959 must be registered with the Selective Service.
- One year supervisory probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

## Qualifications

To be placed into a Cures position, candidates must meet the following criteria:

1. Scientific, Technical, and Professional Fields
2. Qualified and Outstanding Candidates
  - a. **Qualified** applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the [OPM Qualification Standards](#) as a baseline for comparing experience levels and other candidate attributes for relevant positions.
  - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

In order to qualify for this Title 21 Cures position, the candidate(s) must meet the following **required** qualifications. *Please note: Additional education and experience listed that is not indicated as required is preferable and desired. Candidates who do not meet the “desired” criteria will not be excluded from consideration for this position.*

### **Education Requirement:**

**Desired Education:** Undergraduate or graduate education in a major study such as quality assurance, statistics, mathematics, production management, industrial management, computer science, engineering, engineering technology, physical sciences, textiles, or the fields related to the position. **Specialized Experience:** Experience that demonstrated a practical knowledge of monitoring, controlling, or maintaining the quality of products or services in quality assurance, procurement, inspection, production, or related areas.

- Knowledge in monitoring, controlling, or maintaining the quality of products or services in quality assurance, procurement, inspection, production, or related areas
- Demonstrated ability to develop networks and build alliances; collaborates across boundaries to build strategic relationships and achieve common goals
- Ability to identify the internal and external politics that impact the work of the organization. Perceives organizational and political reality and acts accordingly
- Successful experience in implementing quality systems, such as auditing, document control, and CAPA programs
- Demonstrated ability to identify and analyze problems; weighs relevance and accuracy of information; generates and evaluates alternative solutions; makes recommendations
- Successful experience in organizational change management
- Expert ability to communicate, verbally and in writing, and work with staff at all levels of the organization and varying levels of domain expertise; excellent listening skills and a commitment to communicate in a timely manner
- Ability to work independently and as a contributing and collaborative team member
- Ability to organize time effectively, determine priorities, and move work forward

### Education Transcripts

SUBMITTING YOUR TRANSCRIPTS: Positions which are scientific or technical in nature often have very specific educational requirements. A transcript is required to verify educational achievement. Pay careful attention to the Qualifications and Education sections to identify vacancies where a transcript is required. Even if you hold a similar position or are a current FDA employee, you are not exempt from transcript requirements.

FOREIGN EDUCATION: If you are using education completed in foreign colleges or universities to meet the qualification requirements, you must show that the education credentials have been evaluated by a private organization that specializes in interpretation of foreign education programs and such education has been deemed equivalent to that gained in an accredited U.S. education program; or full credit has been given for the courses at a U.S. accredited college or university. Background Investigation/Security Clearance Requirements:

A background security investigation will be required for all appointees.
