Statement of Work

The Laboratory of Vaccine Structure within the Division of Bacterial, Parasitic and Allergenic Products is responsible for evaluating the importance of glycosylation of viral and bacterial antigens as well as pathogen-host carbohydrate dependent interactions. Due to the current SARS-CoV-2 pandemic, the workload has shifted to the analysis of the proteins/ antigens of the SARS-CoV-2 virus, like the Spike protein.

The Spike protein, which is highly glycosylated, is important antigen target in the vaccine production and studying its glycosylation pattern is critical in the host's immune response.

Polysaccharide and other glycoconjugate based vaccines and their components are analyzed using the UltiMate 3000 HPLC instrument, operated by Chromeleon and DCMSLINK F. XCalibur software. The instrument is used to identify structural components of these molecular entities such as, but not limited to, glycopeptides, glycan structures and occupancy sites on proteins. These structural data are required to better define the chemical identity of vaccine components, vaccine candidates and associated glycoconjugates in vaccine research and regulation duties at CBER.

The laboratory requires a Preventive Maintenance and Repair Service contract for an HPLC system as indicated above. The instrument is under a service contract (75F40120P00370) through Sept 27, 2021. This agreement shall include service for a base year plus one (1) option year of service.

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2021-05 effective March 10, 2021.

The associated North American Industry Classification System (NAICS) Code is 811219 - Other Electronic and Precision Equipment Repair and Maintenance, SB Size standard: \$22M. This requirement is solicited as full and open competition and any qualified vendor regardless of size status may submit a quote.

The Contractor shall be responsible for the following:

Minimum Requirements – Preventive Maintenance and Repair Service

The Government requires a base year and one (1) one-year option period of preventive maintenance and repair service for the equipment described herein. Minimum required services are as follows:

1. The Contractor shall provide one (1) on-site preventive maintenance visit per year which includes parts/labor for any preventive maintenance, travel, and any Chromeleon and DCMSLINK F. XCalibur software upgrades necessary. Replacement Parts are covered by the contractor at no additional cost.
2. The Contractor shall provide unlimited on-site repair visit by a factory trained and certified engineer within 2-3 business days and which includes travel and labor.
3. On-Site Preventive Maintenance and Repair activities shall be performed following the Original Equipment Manufacturer (OEM) specifications, manuals, and service bulletins, using OEM-certified replacement parts, components, subassemblies, etc.
4. The Contractor shall guarantee technical support Monday through Friday (excluding Federal Holidays) 8:00AM – 5:00PM Eastern Time.
5. Access by the FDA Contracting Officer's Representative (COR), Technical Representative (TR) and system operator personnel to the manufacturer's call center for technical assistance, which is staffed by senior engineers to provide a high level of expertise for troubleshooting the instrument.
6. The Contractor shall be capable of installing instrument control and data analysis software packages on new computer systems in case of computer system failures.

Deliverables: Service Records and Reports

The Contractor shall, commensurate with the completion of each service call or preventative maintenance visit, provide the end-user of the equipment and the Contracting Officer with a copy of a field service report/ticket identifying the equipment name, manufacturer, model number, and serial number of the equipment being serviced/repared and detailing the reason for the service call, a detailed description of the work performed, the test instruments or other equipment used to affect the repair or otherwise perform the service, the name(s) and contact information of the technician who performed the repair/service, and for information purposes, the on-site hours expended and parts/components replaced.

The price(s) proposed shall represent the offeror's response to the schedule of supplies/services above. Include the firm's DUNS number with quote. The Optional Items will not be funded at time of award. If exercised, funding will be obligated via contract modification; the optional items shall be priced accordingly.

The government is not responsible for locating or securing any information which is not identified in the proposal; the Government reserves the right to obtain information for use in the evaluation from any and all sources including sources outside of the Government.

The Contractor's quote shall also clearly show that the Contractor has selected the appropriate certification under FAR 52.222-48 (see below).

Note: This solicitation is being issued under the premise that the offeror will certify that the combination of equipment maintenance/service it will propose to fulfill this requirement is exempt from the Service Contract Act per the conditions set forth in FAR 52.222-48 & FAR 22.1003-4(c). (b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer’s specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

(a) *Applicability.* This clause does not apply to the extent that the Contractor is supplying end products mined, produced, or manufactured in—

~~(2) Israel, and the anticipated value of the acquisition is \$50,000 or more;~~

~~(3)~~ **[2]** Mexico, and the anticipated value of the acquisition is \$83,099 or more; or

~~(4)~~ **[3]** Armenia, Aruba, Australia, Austria, Belgium, Bulgaria, **[Canada,]** Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary, Iceland, Ireland, Italy, Japan, Korea, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Moldova, Montenegro, Netherlands, New Zealand, Norway, Poland, Portugal, Romania, Singapore, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Taiwan, Ukraine, or the United Kingdom and the anticipated value of the acquisition is \$182,000 or more.

(b) *Cooperation with Authorities.* To enforce the laws prohibiting the manufacture or importation of products mined, produced, or manufactured by forced or indentured child labor, authorized officials may need to conduct investigations to determine whether forced or indentured child labor was used to mine, produce, or manufacture any product furnished under this contract. If the solicitation includes the provision [52.222-18](#), Certification Regarding Knowledge of Child Labor for Listed End Products, or the equivalent at [52.212-3\(i\)](#), the Contractor agrees to cooperate fully with authorized officials of the contracting agency, the Department of the Treasury, or the Department of Justice by providing reasonable access to records, documents, persons, or premises upon reasonable request by the authorized officials.

(c) *Violations.* The Government may impose remedies set forth in paragraph (d) for the following violations:

(1) The Contractor has submitted a false certification regarding knowledge of the use of forced or indentured child labor for listed end products.

(2) The Contractor has failed to cooperate, if required, in accordance with paragraph (b) of this clause, with an investigation of the use of forced or indentured child labor by an Inspector General, Attorney General, or the Secretary of the Treasury.

(3) The Contractor uses forced or indentured child labor in its mining, production, or manufacturing processes.

(4) The Contractor has furnished under the contract end products or components that have been mined, produced, or manufactured wholly or in part by forced or indentured child labor. (The Government will not pursue remedies at paragraph (d)(2) or paragraph (d)(3) of this clause unless sufficient evidence indicates that the Contractor knew of the violation.)

(d) Remedies.

- (1) The Contracting Officer may terminate the contract.
 - (2) The suspending official may suspend the Contractor in accordance with procedures in FAR [subpart 9.4](#).
 - (3) The debarring official may debar the Contractor for a period not to exceed 3 years in accordance with the procedures in FAR [subpart 9.4](#).
