**Statement of Work**

The U.S. Food and Drug Administration (FDA), National Center for Toxicological Research (NCTR), Division of Systems Biology (DSB) requires a microtome and water bath. DSB is developing numerous protocols related to COVID-19 to investigate potential therapeutics and examine scientific knowledge gaps related to human perinatal risks. UTHSC Memphis will collaborate with DSB and conduct the in-life portion of the studies in the COVID-19 Syrian hamster and human Angiotensin Converting Enzyme 2 (hACE2) transgenic mouse model; studies at UTHSC will include SARS-CoV-2 infection, determination of viral load, necropsy, and collection of tissues and blood samples. Virus must be inactivated in all samples prior to shipment out of the BSL3 animal facility (serum/plasma and paraffin blocks). For analyzing histology of tissues from hamster and mice, the FDA lab needs the microtome and water bath for providing paraffin sections and for avoid potential contamination of SARS-Cov-2 virus to other equipment (microtome). The lab has determined that the Epredia HM

325 Rotary Microtome, product number 902100A or equal, will meet its needs, as will the Boekel Scientific Standard lighted tissue flotation bath, product number 145702 or equal.

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2021-05 effective March 10, 2021.

The associated North American Industry Classification System (NAICS) Code is 334516 Analytical Laboratory Instrument Manufacturing. The Small Business Size standard is 1,000 employees. This requirement is solicited as full and open competition and any qualified vendor regardless of size status may submit a quote.

**Minimum Requirements.** Minimum requirements for the products are as follows

1. Rotary Microtome shall be manually operated and include blade holder
2. Microtome shall include a minimum of one-year warranty
3. Water bath shall be for paraffin tissue section preparation and must be lighted tissue flotation bath for 115V operation:
  - “Flotation bath” to stretch paraffin sections
  - Must be rectangle and provide optimal drying on the heated preparation area
  - The working temperature can be adjusted from room temperature to up 60-80 ° C.
  - Can be illuminated for paraffin sections
4. Water bath shall include a minimum 2-year warranty

#### **Trade and Service Specifications**

1. Equipment shall be newly manufactured, not used, refurbished, or previously used for demonstration.
2. Equipment shall be delivered with all necessary supplies and accessories required for installation and start-up.

The Government intends to award a contract resulting from this solicitation to the lowest priced technically acceptable responsible offeror. Offers will be evaluated on their ability to meet the requirements provided herein. The lowest priced offer will be evaluated first. If the lowest priced offeror is not technically acceptable, the next lowest priced offer will be evaluated and so on until a technically acceptable offer is determined.

The Government's determination of technical acceptability in no way relinquishes the Awardee's contractual obligation to ensure the supplies meet the FDA's stated need.

A written notice of award or acceptance of an offer mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

- (a) *Applicability.* This clause does not apply to the extent that the Contractor is supplying end products mined, produced, or manufactured in—
  - (1) ~~Canada, and the anticipated value of the acquisition is \$25,000 or more;~~
  - ~~(2) Israel, and the anticipated value of the acquisition is \$50,000 or more;~~
  - ~~(3)~~**[2]** Mexico, and the anticipated value of the acquisition is \$83,099 or more; or
  - ~~(4)~~**[3]** Armenia, Aruba, Australia, Austria, Belgium, Bulgaria, **[Canada,]** Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary, Iceland, Ireland, Italy, Japan, Korea, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Moldova, Montenegro, Netherlands, New Zealand, Norway, Poland, Portugal, Romania, Singapore, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Taiwan, Ukraine, or the United Kingdom and the anticipated value of the acquisition is \$182,000 or more.
- (b) *Cooperation with Authorities.* To enforce the laws prohibiting the manufacture or importation of products mined, produced, or manufactured by forced or indentured child labor, authorized officials may need to conduct investigations to determine whether forced or indentured child labor was used to mine, produce, or manufacture any product furnished under this contract. If the solicitation includes the provision [52.222-18](#), Certification Regarding Knowledge of Child Labor for Listed End Products, or the equivalent at [52.212-3\(i\)](#), the Contractor agrees to cooperate fully with authorized officials of the contracting agency, the Department of the Treasury, or the Department of Justice by

providing reasonable access to records, documents, persons, or premises upon reasonable request by the authorized officials.

(c) *Violations.* The Government may impose remedies set forth in paragraph (d) for the following violations:

(1) The Contractor has submitted a false certification regarding knowledge of the use of forced or indentured child labor for listed end products.

(2) The Contractor has failed to cooperate, if required, in accordance with paragraph (b) of this clause, with an investigation of the use of forced or indentured child labor by an Inspector General, Attorney General, or the Secretary of the Treasury.

(3) The Contractor uses forced or indentured child labor in its mining, production, or manufacturing processes.

(4) The Contractor has furnished under the contract end products or components that have been mined, produced, or manufactured wholly or in part by forced or indentured child labor. (The Government will not pursue remedies at paragraph (d)(2) or paragraph (d)(3) of this clause unless sufficient evidence indicates that the Contractor knew of the violation.)

(d) Remedies.

(1) The Contracting Officer may terminate the contract.

(2) The suspending official may suspend the Contractor in accordance with procedures in FAR [subpart 9.4](#).

(3) The debarring official may debar the Contractor for a period not to exceed 3 years in accordance with the procedures in FAR [subpart 9.4](#).
