Statement of Work

CBER’s Division of Emerging and Transfusion Transmitted Diseases (DETTD)/Office of Blood Research and Review (OBRR)/Laboratory of Emerging Pathogens (LEP), Malaria and Babesia Laboratory, owns a Bio-Plex 200 System (Serial Number: LX10010350404) which requires a preventive maintenance and repair agreement to ensure for the equipment’s proper function, calibration, and to preserve equipment reliability. The lab also requires a maintenance package on its Bio-Plex Pro II Wash Station (Serial Number: 1009003307), which is an integral part of the Bio-Plex 200.

Neither the Bio-plex 200 nor the wash station are currently covered under a maintenance contract; therefore, the laboratory requires a Preventive Maintenance and Repair Service contract for the Bio-Plex 200 and a depot (mail-in support) service contract for the wash station. This agreement shall include service for a base year plus two (2) option years of service.

The laboratory identified 50 immunodominant *B. microti* antigens of unknown biological function. Among the 50 identified, the four most immunodominant antigens, BmSERA, BmPiBS, BmMCFRP, and BmBAHCS, showed strong reactivity to *B. microti* infected human sera. IFA and ELISA did the measurement of the antibodies. Both assays are reliable but are not high-throughput and detect only a single antigen. To address these limitations, the lab designed a study, “Multiplex antibody bead assay detects early and persistent chronic *Babesia microti* infections in blood donors.”

The multiplex assay will use antigen-coated microsphere beads bound by antibodies present in the *B. microti* infected human serum. A biotinylated detection antibody is added, followed by streptavidin-PE, which serves as the fluorescent indicator, and the lab will read the final reaction in the Bio-Plex 200 system.

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2021-05 effective March 10, 2021.

The associated North American Industry Classification System (NAICS) Code is 811219 - Other Electronic and Precision Equipment Repair and Maintenance, SB Size standard: \$22M. This requirement is solicited as full and open competition and any qualified vendor regardless of size status may submit a quote.

The Contractor shall be responsible for the following:

Minimum Requirements – Preventive Maintenance and Repair Service

The Government requires a base year and two (2) one-year option periods of service for the equipment described herein. Minimum required services are as follows:

Bio-Plex 200 System

1. One-year Full On-Site Complete Support Plan performed by OEM (Original Equipment Manufacturer) specifications. Unlimited repair inclusive of travel, factory-certified replacement parts, and labor by certified Bio-Rad service engineer
2. One preventive maintenance (PM) annually inclusive of travel, factory-certified replacement parts, and labor.
3. Service Monday-Friday, 9 AM-5 PM, excluding Federal Holidays
4. Shall guarantee immediate on-site response within 48 hours
5. Shall provide priority telephone and e-mail access to instrument technical support

Bio-Plex Pro II Wash Station

1. One-year Full Mail in Complete Support Plan. Unlimited repair inclusive of shipping (shipping charges is one way), parts, and labor by certified Bio-Rad service engineer. PM not included.

Deliverables: Service Records and Reports

The Contractor shall, commensurate with the completion of each service call or preventative maintenance visit, provide the end-user of the equipment and the Contracting Officer with a copy of a field service report/ticket identifying the equipment name, manufacturer, model number, and serial number of the equipment being serviced/repared and detailing the reason for the service call, a detailed description of the work performed, the test instruments or other equipment used to affect the repair or otherwise perform the service, the name(s) and contact information of the technician who performed the repair/service, and for information purposes, the on-site hours expended and parts/components replaced.

Offerors are afforded the opportunity to inspect the existing instruments and site, at their own expense, prior to the date set for receipt of quotes by contacting the Contract Specialist/Contracting Officer identified herein to schedule an appointment. Failure to inspect the site will not relieve the successful offeror from fully meeting the requirements of the resulting contract at the price offered.

Paragraph (b)(4). Technical Capability: Will be determined by review of information submitted by the offeror which must provide sufficient technical information necessary for the Government to conclusively determine that the offered services meet or exceed the technical requirements identified above. The Government reserves the right to look to other sources of information (e.g., the Contractor Performance Assessment Reporting System (CPARS), etc.) to support past performance evaluations.

The price(s) proposed shall represent the offeror's response to the schedule of supplies/services above. Include the firm's DUNS number with quote. The Optional Items will not be funded at time of award. If exercised, funding will be obligated via contract modification; the optional items shall be priced accordingly.

The government is not responsible for locating or securing any information which is not identified in the proposal; the Government reserves the right to obtain information for use in the evaluation from any and all sources including sources outside of the Government.

The Contractor's quote shall also clearly show that the Contractor has selected the appropriate certification under FAR 52.222-48 (see below).

Note: This solicitation is being issued under the premise that the offeror will certify that the combination of equipment maintenance/service it will propose to fulfill this requirement is exempt from the Service Contract Act per the conditions set forth in FAR 52.222-48 & FAR 22.1003-4(c). If the Contractor certifies that the company is exempt under the terms and conditions of 52.222-48, then clause 52.222-51 will be applicable to the resulting order. No additional time will be given to an offeror or applicant to correct the document submission and the Government will not inform the offeror or applicant that their submission is non-responsive prior to award. It is the offeror’s or applicant’s responsibility to ensure that all electronic documents submitted do not contain or otherwise use macros.

Technical Capability (i.e., how well the proposed services will meet or exceed the Government’s requirements) and past performance (i.e., when, what, and how well), when combined, are relatively equal in value and collectively more important than price in determining the best value to the government, although price remains a significant consideration.

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. (a) *Applicability.* This clause does not apply to the extent that the Contractor is supplying end products mined, produced, or manufactured in—

(1) ~~Canada, and the anticipated value of the acquisition is \$25,000 or more;~~

~~(2) Israel, and the anticipated value of the acquisition is \$50,000 or more;~~

~~(3) Mexico, and the anticipated value of the acquisition is \$83,099 or more; or~~

~~(4) Armenia, Aruba, Australia, Austria, Belgium, Bulgaria, [Canada,] Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary, Iceland, Ireland, Italy, Japan, Korea, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Moldova, Montenegro, Netherlands, New Zealand, Norway, Poland, Portugal, Romania, Singapore, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Taiwan, Ukraine, or the United Kingdom and the anticipated value of the acquisition is \$182,000 or more.~~

(b) *Cooperation with Authorities.* To enforce the laws prohibiting the manufacture or importation of products mined, produced, or manufactured by forced or indentured child labor, authorized officials may need to conduct investigations to determine whether forced or indentured child labor was used to mine, produce, or manufacture any product furnished under this contract. If the solicitation includes the provision [52.222-18](#), Certification Regarding Knowledge of Child Labor for Listed End Products, or the equivalent at [52.212-3\(i\)](#), the Contractor agrees to cooperate fully with authorized officials of the contracting agency, the Department of the Treasury, or the Department of Justice by providing reasonable access to records, documents, persons, or premises upon reasonable request by the authorized officials.

(c) *Violations.* The Government may impose remedies set forth in paragraph (d) for the following violations:

(1) The Contractor has submitted a false certification regarding knowledge of the use of forced or indentured child labor for listed end products.

(2) The Contractor has failed to cooperate, if required, in accordance with paragraph (b) of this clause, with an investigation of the use of forced or indentured child labor by an Inspector General, Attorney General, or the Secretary of the Treasury.

(3) The Contractor uses forced or indentured child labor in its mining, production, or manufacturing processes.

(4) The Contractor has furnished under the contract end products or components that have been mined, produced, or manufactured wholly or in part by forced or indentured child labor. (The Government will not pursue remedies at paragraph (d)(2) or paragraph (d)(3) of this clause unless sufficient evidence indicates that the Contractor knew of the violation.)

(d) Remedies.

(1) The Contracting Officer may terminate the contract.

(2) The suspending official may suspend the Contractor in accordance with procedures in FAR [subpart 9.4](#).

(3) The debarring official may debar the Contractor for a period not to exceed 3 years in accordance with the procedures in FAR [subpart 9.4](#).
