This is to notify you that your request to update the Instructions for Use (IFU) of the TaqPath COVID-19 Fast PCR Combo Kit 2.0 to: (1) update saliva specimen stability claims to -70° C for up to seven weeks, (2) update reagent refrigerated storage conditions to seven hours and up to five freeze/thaw cycles, (3) addition of a limitation related to circulating variants, and (4) additional minor edits for clarity is granted. Upon review, we concur that the data and information submitted in EUA210384/S001 supports the requested updates for use with the TaqPath COVID-19 Fast PCR Combo Kit 2.0. FDA has updated the Healthcare Provider and Patient Fact Sheets and requested edits to the Product Information Card to reflect language used in more recent authorizations.
