2. Limitations

A. HHS Operating Divisions are authorized to set annual pay, including pay increases, for SBRBPAS members up to \$275,000 per annum. Annual pay exceeding this amount must be approved in writing by the Secretary or designee prior to its effective date per HHS Instruction 42-3-80. B.

3. Redelegations.

- A. Designees must be certified as knowledgeable about the legal, regulatory, and policy requirements regarding the subject authorities and they are subject to compliance audits.
- B. Designees must be appointed in writing.
- C. A copy of the designee appointment must be furnished to the OO/OHCM Director, the OO/OTS Chief Talent Officer, and the Principal Delegation Control Officer.
