Availability Update for Emergency Syringes

Dear Customer,

Pfizer Hospital is committed to providing timely supply information so that you can plan for patient care. The purpose of this letter is to share the latest information on supply constraints within our emergency syringe portfolio, including current next delivery and estimated recovery dates.

The supply impacts to Pfizer's emergency syringe products are the result of a complex combination of factors including significant and sustained increases in demand for products across our portfolio, largely due to competitor shortages as well as other COVID-19 related impacts and isolated manufacturing delays, many of which have now been resolved. While Pfizer has worked to meet this increased demand, which is well above our historical volumes, the market need continues to outpace Pfizer's production capacity.

Pfizer is prioritizing emergency syringe manufacturing enhancements and actively working to address these challenges and return to healthy inventory levels. While operations have now stabilized and product releases are ongoing, we now anticipate full supply recovery—when we have sufficient inventory available to meet historical demand projections in addition to several weeks of safety stock in our distribution centers—between March 2022 and January 2023, depending on the presentation, as noted in the next delivery and recovery estimates in the table below, current as of the date of this letter.
