Duties include:

The selected employee will serve as a Program Analyst in the Division of Regulatory Project Management (DRPM) in the Office of Science (OS). Administrative staff perform analysis assignments where the employee applies qualitative and quantitative methods for the analysis and evaluation of internal, organizational program operations, as well as performs analysis and advisory assignments related to the effectiveness of Regulatory Science and Management programs and/or the efficiency of management operations. The incumbent performs a number of duties as described in the following:

- Reviews and evaluates the efficiency of established program policies and procedures to identify any problems.
- Identifies and proposes additional policies or procedures, or resolutions and modifications to improve the efficiency and effectiveness of current program operations.
- Consistently and independently develops, adapts, and employs appropriate qualitative and quantitative methods, procedures and systems for assessing the efficiency and effectiveness of programs; program policies, practices and procedures; and program-level administrative operations, processes and mechanisms.
- Works with information technology staff to design and develop systems.
- Prepares recommendations to management and program officials on routine aspects of programmatic related policies and procedures to include research programs.

- Works with managers and program officials in determining steps or actions to be taken to accomplish work in adherence to requirements.
- Consistently demonstrates strong working technical knowledge and competencies in areas of basic principles and limitations of biological and physical science, manufacturing, public health policies, and regulation of tobacco products.
- Sufficiently demonstrate knowledge of and skills in written and oral communications, presenting information in a concise, clear, organized, professional, and coherent manner.
- Performs other duties as assigned.

Desired Knowledge and Skills:

- Knowledge of a range of qualitative and/or quantitative methods for assessment and improvement of complex program effectiveness.
- Skill with analyzing and evaluating the efficiency and effectiveness of agency programs; select appropriate qualitative and quantitative techniques for a specific situation; and develop and apply new approaches for conducting complex, comprehensive studies which deal with major issues affecting program management.
- Ability to develop studies that address specific problems, issues, and challenges that confront program managers in the organization.
- Skill in working collaboratively.
- Excellent oral and written communication skills.
