#### **Introduction**

The Food and Drug Administration (FDA or Agency) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The Center for Biologics Evaluation and Research (CBER) is a Center within FDA that regulates biological products for human use under applicable federal laws, including the Public Health Service Act and the Federal Food, Drug, and Cosmetic Act. CBER's mission is to protect and enhance the public health through the regulation of biological and related products including blood, vaccines, allergenics, tissues, and cellular and gene therapies. CBER protects and advances the public health by ensuring that biological products are safe, effective, and available to those who need them. CBER also provides the public with information to promote the safe and appropriate use of biological products.

#### **Duties/Responsibilities**

The incumbent serves as the Division of Acquisitions and Budget Resources (DABR) Budget Planning and Execution Branch (BPEB) Branch Chief and manages the daily operations of the Branch. As Branch Chief, the incumbent

provides comprehensive management and operational activities related to all funding types within CBER. The Branch Chief reports to the DABR Division Director.

Specifically, the Branch Chief will:

- Provide comprehensive management and operational activities related to all funding types within CBER.
- Responsible for directing the planning, organization, and execution of various analytical studies involving the substance of major CBER programs and policies associated with the CBER budget program.
- Responsible for the development, defense, and presentation of all budget management data.
- Provide expert advice and assistance to top Center management on the most complex issues related to the administration of the Center's budget and financial management programs.
- Manage budget and resource management and operational activities related to financial operating, resource spending, reimbursable Interagency agreements, and refund plans using the various User Fees.
- Responsible for managing the Center payroll and full-time equivalent activity and supports the payroll functions utilizing the agency Integrated Budget Acquisition Planning System (IBAPS) and the Center Biologics Planning Execution and Reporting System (BPERS).
- Review and approve travel requests for both domestic and international travel, as well as manage the Center's travel operations for all local, domestic, and international requests in coordination with other Agency components.

#### **Supervisory responsibilities:**

**Organizational Management:** Manages a Branch.

**Program Management:** Runs multiple projects. Identifies best uses of available resources to achieve tasks. Identifies projects needed to achieve activities.

**Resource Management:** Determines best use of resources to achieve tasks. Identifies resource needs for multiple projects.

**Personnel Performance Management:** Counsels and rates immediate subordinates.

**Human Capital Management:** Conducts or arranges actions to meet employee competency goals; identifies personnel in need of competencies.

#### **Conditions of Employment**

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.
- Males born after December 31, 1959 must be registered with the Selective Service.
- One year supervisory probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

#### **Qualifications**

To be placed into a Cures position, candidates must meet the following criteria:

1. Scientific, Technical, and Professional Fields
2. Qualified and Outstanding Candidates

- a. **Qualified** applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the [OPM Qualification Standards](#) as a baseline for comparing experience levels and other candidate attributes for relevant positions.
- b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

In order to qualify for this Title 21 Cures position, the candidate(s) must meet the following **required** qualifications. *Please note: Additional education and experience listed that is not indicated as required is preferable and desired. Candidates who do not meet the “desired” criteria will not be excluded from consideration for this position.*

#### **Education Requirement:**

Desired Professional Experience – ideally the candidate has experience in:

- Coordinating and integrating complex budget and financial management program segments.
- Supervising budget and finance team setting goals and expectations in a clear manner to all team members.
- Motivating groups to accept opinions or take actions related to advancing the fundamental goals and objects of budget and financial management programs.
- Knowledge of HHS appropriation policies and statutes.
- Experience with budget planning processes in both operating and payroll environments for purposes of Fiscal Operating Plan (FOP) creation and submission.
- Knowledge of active travel policies and the HHS Travel Manual.
- Experience working in HHS wide systems (UFMS, ConcurGov (CGE), etc.).
- Communicating with staff at all levels of a federal organization including, but not limited to Agency Executives, Directors, Deputy Directors.

#### Education Transcripts

**SUBMITTING YOUR TRANSCRIPTS:** Positions which are scientific or technical in nature often have very specific educational requirements. A transcript is required to verify educational achievement. Pay careful attention to the Qualifications and Education sections to identify vacancies where a transcript is required. Even if you hold a similar position or are a current FDA employee, you are not exempt from transcript requirements.

#### Security Clearance Requirements

**Background Investigation/Security Clearance Requirements:** Background Investigation/Security Clearance is required. All employees must pass a security investigation.
