Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over-the-counter (OTC) and prescription drugs, including biological therapeutics and generic drugs.

The mission of the Office of Generic Drugs (OGD) and its sub-offices is to ensure high-quality, affordable generic drugs are available to the American public. OGD is the world leader in the science and regulation of generic drugs serving an essential role in advancing FDA's public health mission.

The Office of Generic Drug Policy (OGDP) serves as the Agency's lead on generic drug policy and regulation to enable generic drug approvals and provide the public with high quality, affordable medicines. We achieve this by advocating on behalf of the generic drug program and providing counsel in a complex, ever-changing legal and regulatory environment.

Duties/Responsibilities

As the **Director** with the Office of Generic Drug Policy (OGDP), the incumbent serves as the principal administrative, technical, and regulatory authority on all matters related to generic drug regulatory authorities. Represents OGD on policy development for and implementation of the Generic Drug User Fee Amendments (GDUFA) of 2012 and its reauthorization in the Food and Drug Administration Reauthorization Act (collectively, GDUFA) within FDA, and with other Agencies, Congress, and regulated industry. Manages highly complex and difficult assignments of national and international scope and significance.

- Serves as the regulatory expert for generic drug regulation in OGD, CDER, and FDA.
- Oversees the development of policies and procedures involving the most complex and highest priority issues affecting the regulation of generic drug products, including GDUFA.
- Directs and influences subordinates' policy document development on issues that are industry-wide in scope or have broad health-policy implications and that concern precedent-setting interpretations of FDA policies affecting the regulation of generic drug products.
- Reviews policy and other regulatory documents drafted by other Offices that impact the generic drug regulation. Reviews draft revisions and technical corrections to new and existing regulatory documents.
- Advises OGD, CDER, and FDA on policy documents, inquiries, and/or proposals regarding generic drug regulation received from internal agency entities, external stakeholders including regulated industry, senior agency and department officials, Congress, the media, and public health advocacy groups.
- Manages and directs subordinate management and staff resolution of a broad range of issues concerning the implementation of FDA's enabling statutes, including those related to generic drug regulation and the Hatch-Waxman Amendments to the Federal Food, Drug, and Cosmetic (FD&C) Act, pertinent regulations, guidance documents, standard operating procedures, and other policy documents related to the regulation of generic drug products.
- Decides on changes and additions to the functions, program segment(s), and activities of OGDP necessary to implement new legislation or regulations and develops various scenarios for dealing with expansion or contraction of OGDP's functions, programs, and activities.

Supervisory Responsibilities:

Provides occupational-specific technical and administrative direction to subordinate supervisors performing the work and functions of the organization 25 percent or more of the time. Obtains resources and identifies strategic objectives for the organization.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.
- Males born after December 31, 1959 must be registered with the Selective Service.
- One-year probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

- Expert ability to communicate and work with staff at all levels of the organization and varying levels of domain expertise; demonstrated ability to collaborate across boundaries to build strategic relationships and achieve common goals.
- Ability to work independently and as a contributing, collaborative team member.
- Ability to organize time effectively, determine priorities, and move work forward.

Education Transcripts

Security Clearance Requirements

Background Investigation/Security Clearance Requirements: Non-Sensitive/High Risk

If not previously completed, a background security investigation will be required for all appointees.
