

## Advisory Committee Member

**INTRODUCTION:** The Center for Devices and Radiological Health ([CDRH](#)), a major regulatory component of the Food and Drug Administration ([FDA](#)) and the Department of Health and Human Services (HHS) is requesting nominations for members to serve on one of our 17 Medical Devices Advisory Committee ([MDAC](#)) panels. The MDAC's advise the Commissioner about issues related to the safety and effectiveness of medical devices. Each committee consists of experts with recognized expertise and judgment in a specific field.

**TERM:** 2-4 years

**FREQUENCY:** 1-4 meetings per year

**SALARY AND TRAVEL EXPENSES:** Members are appointed as Special Government Employees and receive a salary for each meeting day as well as travel and per diem costs.

**QUALIFICATIONS:** Persons nominated must be experts in their field (e.g., clinical medicine, engineering, biological and physical sciences, and biostatistics) and have experience in medical practice, teaching, and/or relevant research. Selections are based on the expertise required to meet its specific needs. Every effort will be made to ensure appropriate balance of membership. CDRH seeks nominations of qualified candidates without regard to race, color, religion, sex, sexual orientation, gender identity, national origin, disability, or protected veteran status. **OPEN PERIOD:** Nominations will be accepted on a continuing basis. Selections will be determined by the expertise needed to fill an existing or anticipated vacancy.

**WHAT TO SEND:** Nominations of qualified individuals must include:

- Complete curriculum vitae and bibliography of each nominee

- A written confirmation that the nominee is aware of the nomination (unless self nominated)
- Letter(s) of Recommendation
- Potential candidates will be asked to provide detailed information concerning financial holdings, employment, and research grants and contracts to identify any potential [conflict of interest](#).
