Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and that all such products marketed in the United States are adequately, truthfully and informatively labeled and safely and properly stored, transported, manufactured packaged and regulated. FDA's programs are national in scope and effect, and the agency's activities have a direct and significant impact on multibillion-dollar industries, in addition to protecting the health and safety of American Consumers. The work of the Agency is carried out by a staff of more than 18,000 scientist, physicians, regulatory and other personnel stationed throughout the United States.

The mission of the Office of Digital Transformation (ODT) is to provide high quality, secure, and efficient IT and data solutions that enable the FDA to promote and protect the public health. This position is located in the Office of Data, Analytics, and Research (ODAR) which is responsible for Data Analytics, and Research and development.

Duties/Responsibilities

- Serve as an advisor to the Chief Data Officer and senior management officials across FDA
- Advance applied use of Artificial Intelligence (AI) broadly, including but not limited to capabilities, such as Natural Language Processing (NLP) and Machine Learning (ML), across the agency.
- Advance the agency's strategic vision for applying AI, developing project plans and guiding execution teams, and serving as an expert consultant to the Chief Data Officer (CDO) and agency's leadership. In addition, you will provide input on policy issues regarding the use of AI in the Department of Health and Human Services (DHHS).
- Provide strategic leadership and supervision for a growing AI team and driver projects that utilize ML/NLP/Robotic Processing Automation (RPA) technologies to address high value enterprise needs
- Promote and execute the adoption of best practices through teaching, coaching, establishment of governance, knowledge collation and delivery in application of AI/ML
- Practice a product mindset when prioritizing collaborative and user-centered development leading to sustainable solutions in AI/ML projects
- Serve as a member of the Senior Leadership Team, providing back-end operations thought leadership spanning the entire enterprise
- · Other duties as assigned

Conditions of Employment

Qualifications

To be placed into a Cures position, candidates must meet the following criteria:

- Scientific, Technical, and Professional Fields
- Qualified and Outstanding Candidates
 - a. Qualified applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the <u>OPM Qualification Standards</u> as a baseline for comparing experience levels and other candidate attributes for relevant positions.
 - b. *Outstanding* candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

In order to qualify for this Title 21 Cures position, the candidate(s) must meet the following <u>required</u> qualifications. *Please note: Additional education and experience listed that is not indicated as <u>required</u> is preferable and desired. Candidates who do not meet the "desired" criteria will not be excluded from consideration for this position.*

Education Requirement: For all positions individuals must have IT-related experience demonstrating each of the four competencies listed below. The employing agency is responsible for identifying the specific level of proficiency required for each competency at each grade level based on the requirements of the position being filled.

- 1. **Attention to Detail** Is thorough when performing work and conscientious about attending to detail.
- 2. Customer Service Works with clients and customers (that is, any individuals who use or receive the services or products that your work unit produces, including the general public, individuals who work in the agency, other agencies, or organizations outside the Government) to assess their needs, provide information or assistance, resolve their problems, or satisfy their expectations; knows about available products and services; is committed to providing quality products and services.
- 3. **Oral Communication** Expresses information (for example, ideas or facts) to individuals or groups effectively, taking into account the audience and nature of the information (for example, technical, sensitive, controversial); makes clear and convincing oral presentations; listens to others, attends to nonverbal cues, and responds appropriately.
- 4. **Problem Solving** Identifies problems; determines accuracy and relevance of information; uses sound judgment to generate and evaluate alternatives, and to make recommendations.

Experience in Information Technology demonstrated by paid or unpaid experience and/or completion of specific of intensive training (for example, accredited IT certification in AI/ML) as appropriate.

<u>Desired Education</u>: A Bachelor's or advanced degree in computer science, engineering, information science, information systems management, mathematics, operations research, statistics, or technology management. Accredited certification in AI/ML will be desirable.

<u>Professional Experience:</u> Incumbent must have one year of specialized experience in AI/ML providing executive level leadership to technical staff; advising senior leadership; overseeing business operations; utilizing technical expertise to establish information technology-based policy guidance; and managing or implementing budget strategies to meet program priorities.

<u>Desired Professional Experience</u>:

- The ideal candidate will have previously served in a leadership capacity for a minimum of 3
 years in the use of advanced analytics or process automation; be experienced in stakeholder
 management with technical and non-technical audiences; and will have leadership
 experience in the healthcare, public health, or biomedical research field to apply to the business of
 the FDA
- Experience in leadership for an AI or Automation team to deliver projects utilizing ML, NLP and/or RPA for high-value enterprise needs; Experience in leading executive briefings and stakeholder workshops focused on AI / ML strategy and roadmap development
- Demonstration of AI/ML domain knowledge through publications or presentations in recognized ML journals or conferences.
- Ability to collaborate with x-functional teams to drive adoption of AI/ML solutions that leverage natural language processing, computer vision, statistical learning theory.
- Leading cross-functional stakeholders to meet strategic objectives; Garnering support for the team
 by persuading others to provide approval, funding, or resources; and/or Adjusting strategy based on
 qualitative or quantitative strategy
- Building impactful solutions that utilize AI techniques such as supervised learning (e.g., predictive analytics, classification), unsupervised learning, natural language processing, and/or deep learning
- Building end-to-end software pipelines to execute machine learning/AI solutions, preferably in the cloud environment (e.g., AWS stack, Apache Kafka, Logstash, etc.)
- Implementing best practices for AI lifecycle management, monitoring tools for production quality continuous development of models, and machine learning operations (e.g., "MLOps" design, MLFlow, Kubeflow, Pachyderm)
- Implementing AI systems, including the ethical, legal, and societal concerns
- Analyzing the advantages and disadvantages of applying new technologies and workflows, and articulating the tradeoffs to technical and non-technical audiences
- Implementation and conceptual knowledge of various technologies and framework to achieve business solutions

Education

Security Clearance Requirements

Background Investigation/Security Clearance Requirements: Non-Critical Sensitive

This position requires a Non-Critical Sensitive security clearance, and the incumbent has access to documents and facilities related to national security.
