Statement of Work

The U.S. Food and Drug Administration's (FDA)/National Center for Toxicological Research (NCTR), Jefferson, AR, requires a Potentiostat that is capable of performing cyclic voltammetry measurement and electrochemical impedance spectroscopy measurements.

The Food and Drug Administration (FDA) makes regulatory assessments of products that either contain nanomaterial or otherwise involve the application of nanotechnology. The FDA Nanotechnology Core (Nanocore) Facility supports the nanotechnology needs of National Center for Toxicological Research (NCTR) and the Office of Regulatory Affairs/ Arkansas Regional Laboratory (ORA/ARL), which are co-located on the Jefferson Laboratories Campus. The facility also supports studies conducted under the National Toxicology Program and other FDA Centers. Nanocore conducts research on characterization of nanomaterials and their biological assessment to facilitate regulatory decision-making. Nanocore also develops consensus standards in collaboration with stakeholders.

The FDA has identified a Potentiostat Module that meets its requirements: Metrohm's PGSTAT128N with EIS and pH module capability. The system allows for cyclic voltammetry with electrochemical impedance spectroscopy along with pH measurements and is one of the methods for determining thin film deposition on quartz crystal sensors.

Instrument Salient Characteristics/General Requirements:

1. The potentiostat shall have voltage range or compliance of at least +/- 10V and minimum

potential or voltage resolution of at least 5 micro volts.

2. The system shall have current range of at least 1 ampere to 0.01 micro amperes with current resolution of at least 0.0005% of the current range.
3. The electrochemical impedance spectroscopy shall have frequency range of at least 10 microhertz to 1 megahertz.
4. The system shall be set up in such a way that additional options or accessories can be added. Also, the module shall have the flexibility to upgrade and/or add options at later date such as the ability to take EIS up to 10 MHz and add a low current amplifier to obtain a current resolution ≤ 0.5 fA.
5. The system shall include slots for attachment of electrodes for current-voltage measurement as required for cyclic voltammetry.
6. The electrochemical impedance spectroscopy capability shall have amplitude range of at least 0.2 mV to 0.4V.
7. The system shall have options for adding temperature and pH probes to record in-situ temperature and pH measurements during CV or amperometric measurements with a measured current resolution of ~ 30 fA.
8. The system shall include one counter electrode (Platinum), one working electrode (glassy carbon), and one reference electrode (silver/silver chloride containing potassium chloride electrolyte).
9. The system shall include all accessories such as clips and cables required for connecting three electrodes and one additional probe to the potentiostat.
10. The system shall include one titration vessel, lid for the titration vessel having separate ports for working, reference, and counter electrodes, and two additional probes (such as pH, temperature, etc.), stoppers for the ports, and a glass gas inlet and outlet transfer tube. Any clamps or stand required for holding the titration vessel, electrodes and probes should also be included.
11. Software with capabilities for method set up, method control, data recording and data analysis compatible with WIN 10 shall be provided.

Training and Additional System Requirements:

1. The components and equipment shall be a newly manufactured, not used or refurbished, or previously used for demonstration.
2. Instrument shall be warranted for not less than one (1) year from FDA acceptance, to include training. Warranty service shall include troubleshooting capabilities based on complete knowledge of the entire system, immediate access to replacement parts, and immediate access to system improvements and updates. Phone and email technical support shall be included for a minimum of one (1) year.
3. The instrument shall be delivered with all necessary supplies and accessories required for installation and start-up.
4. The instrument shall include operations and maintenance manuals covering proper operation, routine maintenance, and troubleshooting for the instrument and controlling

software. All manuals and documentation shall be provided in hard copy and/or electronic format.

Deliverables: Service Records and Reports: The Contractor shall, commensurate with the completion of each service, provide the end-user of the equipment with a copy of a field service report/ticket identifying the equipment name, manufacturer, model number, and serial number of the equipment being serviced, a detailed description of the work performed, the test instruments or other equipment used to perform the service, the name(s) and contact information of the technician who performed the service, and for information purposes, the hours expended, and parts/components replaced. In addition, the Contractor shall provide a written report to the FDA COR and Contract Specialist, summarizing all maintenance activities (including warranty work) each time service is performed.

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2022-06 effective May 26, 2022.

The associated North American Industry Classification System (NAICS) code for this acquisition is 334516 – Analytical Laboratory Instrument Manufacturing; the applicable Small Business Size Standard is 1,000 employees. This requirement is set aside 100% for small business; only small businesses under the aforementioned NAICS may submit a quote.

FDA Attestation and COVID-19 Testing Screening Procedures for Onsite Work at an FDA Facility

On April 22, 2022, HHS posted a notice to SAM.gov outlining procedures for access control regarding onsite contractor attestation of vaccination or evidence of negative COVID-19 test results and can be found here: <https://sam.gov/opp/b85251f1555c40dfae55adf651e18f5a/view>. The notice outlines the use of the Contracting Officer Representative (COR)/Technical Point of Contact (TPOC) or his/her designee to facilitate this process.

FDA has developed a process that should be followed in FDA facilities based upon medium or high COVID-19 Community Levels in an area.

The COR/TPOC or Designee should validate compliance prior to any Contractor or visitor reporting on-site at an FDA facility.

Similar to FDA's face covering/mask policy, each individual is responsible for checking the current CDC COVID-19 Community Level for their respective FDA facility and implementing this compliance check for contractors who will be working on-site if the facility CDC COVID-19 Community Level is Medium or High.

The Contractor shall maintain a copy of either their Certification of Vaccination form or result of a negative COVID-19 test within the last 72 hours and must always have it available with them to present to the COR/TPOC or Designee upon request.

Onsite Contractors who are not yet fully vaccinated, unvaccinated, or decline to disclose their vaccination status and who are unable to show proof of a negative test within the last 72 hours, may be asked to leave the facility. The COR/TPOC or Designee shall then notify their Contracting Officer (CO) that this action was taken.
