Statement of Work

The U.S. Food and Drug Administration (FDA)'s Center for Food Safety and Applied Nutrition (CFSAN), Office of Applied Research and Safety Assessment, Division of Molecular Biology has an Omnilog system (manufactured by Biolog, Inc.) to conduct phenotypic microarray (PM) experiments and requires a full-service maintenance contract for the Omnilog system in order to keep the instrument functioning properly so that it can take accurate and reproducible readings. This requirement includes replacement of parts of the instrument that are not working as well as upgrades of all software to run the instruments and analyze the data.

A full-service plan is required on Omnilog Biolog instrument SN193 and a Preventative Maintenance plan only is required on Omnilog Biolog instrument SN191. Both instruments are located at FDA 8301 Muirkirk Rd, Laurel MD 20708 and are operating normally. SN193 is covered under maintenance contract number 75F40119P10563 through Sept 5, 2022, so the new contract will pick up where that one expires.

Maintenance Requirements for the Full-Service Plan: (for the Omnilog system, SN193)

- One (1) planned on-site preventive maintenance visit per contract year, to include all associated labor, travel, and expenses.
- Unlimited number of on-demand, on-site corrective maintenance visits including all associated labor, travel, and expense costs.
- All maintenance activities shall be performed by formally trained and certified technicians and/or engineers, following Original Equipment Manufacturer (OEM) specifications, manuals, and service bulletins, using OEM replacement parts, components, subassemblies, etc.
- Telephone technical support and routine troubleshooting.
- Response time within 3-5 business days after receipt of service call if issue cannot be corrected remotely within 8 hours from call for service
- All product enhancements including software updates.
- Replacement parts costs will be covered by the vendor. Labor and travel costs are covered by the vendor.

Maintenance Requirements for the PM Plan: (for the Omnilog system, SN191)

- One (1) planned on-site preventive maintenance visit per contract year for routine issues, to include all associated labor, travel, and expenses.
- All maintenance activities shall be performed by formally trained and certified technicians and/or engineers, following Original Equipment Manufacturer (OEM) specifications, manuals, and service bulletins, using OEM replacement parts, components, subassemblies, etc.
- Telephone technical support and routine troubleshooting.
- Response time within 3-5 business days after receipt of service call if issue cannot be corrected remotely within 8 hours from call for service
- All product enhancements including software updates.
- Labor and travel costs are covered by the vendor.

Deliverables: Service Records and Reports: The Contractor shall, commensurate with the completion of each service, provide the end-user of the equipment with a copy of a field service report/ticket identifying the equipment name, manufacturer, model number, and serial number of the equipment being serviced, a detailed description of the work performed, the test instruments or other equipment used to perform the service, the name(s) and contact information of the technician who performed the service, and for information purposes, the hours expended, and parts/components replaced. In addition, the Contractor shall provide a written report to the FDA COR and Contract Specialist, summarizing all maintenance activities (including warranty work) each time service is performed.

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2022-06 effective May 26, 2022.

The associated North American Industry Classification System (NAICS) code for this acquisition is 811219 – Other Electronic and Precision Equipment Repair and Maintenance; the applicable Small Business Size Standard is \$22 million. This requirement is set aside 100% for small business; only small businesses under the aforementioned NAICS may submit a quote.

FDA Attestation and COVID-19 Testing Screening Procedures for Onsite Work at an FDA Facility

On April 22, 2022, HHS posted a notice to SAM.gov outlining procedures for access control regarding onsite contractor attestation of vaccination or evidence of negative COVID-19 test results and can be found here: <https://sam.gov/opp/b85251f1555c40dfae55adf651e18f5a/view>. The notice outlines the use of the Contracting Officer Representative (COR)/Technical Point of Contact (TPOC) or his/her designee to facilitate this process.

FDA has developed a process that should be followed in FDA facilities based upon medium or high COVID-19 Community Levels in an area.

The COR/TPOC or Designee should validate compliance prior to any Contractor or visitor reporting on-site at an FDA facility.

Similar to FDA’s face covering/mask policy, each individual is responsible for checking the current CDC COVID-19 Community Level for their respective FDA facility and implementing this

compliance check for contractors who will be working on-site if the facility CDC COVID-19 Community Level is Medium or High.

The Contractor shall maintain a copy of either their Certification of Vaccination form or result of a negative COVID-19 test within the last 72 hours and must always have it available with them to present to the COR/TPOC or Designee upon request.

Onsite Contractors who are not yet fully vaccinated, unvaccinated, or decline to disclose their vaccination status and who are unable to show proof of a negative test within the last 72 hours, may be asked to leave the facility. The COR/TPOC or Designee shall then notify their Contracting Officer (CO) that this action was taken.

If not the OEM, offerors shall provide demonstrated and verifiable prior experience providing the same or near-same maintenance, repair, and support activities for this OEM equipment (Omnilog Biolog instrument SN193 and SN191) to include a verifiable established supply chain with that OEM for specifications, manuals, bulletins, software and firmware updates, parts, components, subassemblies, etc.

The Quoter shall submit a written Accessibility Conformance Report (ACR) for each item not in compliance with 508 standards identified in clause 352.239-74, describing how the item(s) will fully address the accessibility requirements outlined in the solicitation; and a description of the evaluation methods the offeror will use to validate for conformance to the Revised 508 Standards. The ACR should be based on the Voluntary Product Accessibility Template Version 2.0 (MS Word) provided by the Industry Technology Industry Council (ITIC). **For this requirement we anticipate only service records and reports and invoices to be applicable to this requirement.**

Offerors are afforded the opportunity to inspect the instrument by contacting the Contract Specialist identified herein to schedule an appointment. Failure to inspect the system will not relieve the successful offeror from fully meeting the requirements of the resulting contract at the price offered.

Price proposed must be detailed and represent the offeror's response to the schedule of items. Any pre-inspection fees shall be included in the price.

The Government is not responsible for locating or securing any information which is not identified in the proposal; however, the Government reserves the right to obtain information for use in the evaluation from any and all sources including sources outside of the Government.

Responses are due by e-mail no later than the date and time listed on page 1 of this document. Offerors shall include the firm's SAM UEI number and GSA Contract # (if applicable) with quote.

This solicitation is issued under the premise that the offeror will certify that the maintenance services are exempt from the Service Contract Act per the conditions set forth in the provision at FAR 52.222-48 & FAR 22.1003-4(c). If this is the case and the Contractor certifies that is exempt under the terms and conditions of 52.222-48, then clause 52.222-51 will flow per usual from this solicitation to the resulting order. In the event that a Contractor does not make this certification, traditional Service Contract Act clause 52.222-41 shall be included in the resulting order award as well as Wage Determination No. WD 2015-4281 (Rev. 24), 06/26/2022, and can be found at the following link: <https://sam.gov/wage-determination/2015-4281/24> .

No additional time will be given to an offeror or applicant to correct the document submission and the Government will not inform the offeror or applicant that their submission is non-responsive prior to award. The Government will award a contract resulting from this solicitation to the lowest priced technically acceptable responsible offeror. Offers will be evaluated on their ability to meet the requirements provided herein. The lowest priced offer will be evaluated first. If the lowest priced offeror is not technically acceptable, the next lowest priced offer will be evaluated and so on until a technically acceptable offer is determined.

Technical acceptability will be determined by review of information submitted by the Offeror which must provide a description in sufficient detail to show that the proposed preventive maintenance/repair service meets the Government's requirements and demonstrates successful performance of the product and/or services.

Options: N/A.

A written notice of award or acceptance of an offer mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer’s specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.
