This is to notify you that your request to update the OHC COVID-19 Antigen Self Test to (1) extend the shelf-life expiration date to 12 months when stored at 2°C – 30°C, based on the results of your ongoing stability studies, (2) offer the OHC COVID-19 Antigen Self Test under the brand name/trade name of QuickFinder COVID-19 Antigen Self Test, (3) add authorized distributors for the QuickFinder COVID-19 Antigen Self Test, and (4) add a QR code to the test cassette, is granted.
