Introduction

The Food and Drug Administration (FDA or Agency) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The Center for Biologics Evaluation and Research (CBER) is a Center within FDA that regulates biological products for human use under applicable federal laws, including the Public Health Service Act and the Federal Food, Drug, and Cosmetic Act. CBER's mission is to protect and enhance the public health through the regulation of biological and related products including blood, vaccines, allergenics, tissues, and cellular and gene therapies. CBER protects and advances the public health by ensuring that biological products are safe, effective, and available to those who need them. CBER also provides the public with information to promote the safe and appropriate use of biological products.

Duties/Responsibilities

The incumbent serves as the Branch Chief of the Acquisition Management Branch (AMB) in the Division of Acquisitions and Budget Resources (DABR) and manages the daily operations of the Branch.

Specifically, the Branch Chief will:

- Provide an internal control structure to provide efficient and effective services related to acquisitions and assistance.
- Direct the administration and coordination of the CBER ongoing extramural research, services contracts, and interagency agreements (IAGs) and small purchase programs.
- Conduct acquisition planning and execution consisting of developing required procurement documentation, coordinating with budget execution, and facilitate the execution of FDA fellows through various fellowship programs.
- Oversee the management of Center contract and grant proposals.
- Provide acquisition support, develops and maintains a relationship with the Office of Acquisitions and Grants Services (OAGS), and directs the administration and coordination of CBER ongoing extramural research, services contracts, and Interagency Agreements (IAGs).
- Oversee the program management of financial and acquisitions information in support of the FDA/CBER mission.

Supervisory responsibilities:

Organizational Management: Manages a Branch.

Program Management: Runs multiple projects. Identifies best uses of available resources to achieve tasks. Identifies projects needed to achieve activities.

Resource Management: Determines best use of resources to achieve tasks. Identifies resource needs for multiple projects.

Personnel Performance Management: Counsels and rates immediate subordinates.

Human Capital Management: Conducts or arranges actions to meet employee competency goals; identifies personnel in need of competencies.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.
- Males born after December 31, 1959 must be registered with the Selective Service.
- One year supervisory probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

Qualifications

To be placed into a Cures position, candidates must meet the following criteria:

1. Scientific, Technical, and Professional Fields
2. Qualified and Outstanding Candidates
 - a. **Qualified** applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the [OPM Qualification Standards](#) as a baseline for comparing experience levels and other candidate attributes for relevant positions.
 - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

Desired Professional Experience - our ideal candidate will possess:

- Leadership coaching, training, or certification;
- Prior management and/or operations experience with the FDA;
- Expertise in acquisitions, procurement, and funding processes;
- Ability to build and work effectively within teams;
- Ability to work collaboratively with diverse staff and stakeholders; and
- Ability to prioritize and make critical decisions.
- Experience with multiple aspects of federal acquisition processes including but not limited to:
 - Acquisition Planning
 - Acquisition Pre-Awards for simplified and complex requirements
 - Acquisition Administration
 - Acquisition Close-Out
- Experience in supervising acquisitions teams in setting goals and expectations in a clear manner to all members.
- Motivating groups to accept opinions or take actions related to advancing fundamental goals and objects of acquisitions programs.
- Knowledge of HHS Federal Acquisition related systems
- Experience supervising or coordinating acquisitions programs pertaining to statements of work, performance work statements, statements of objectives, independent government cost estimates, paying invoices, contract close-outs, grants, purchase cards, and/or broad agency announcements.
- Experience and familiarity with the Federal Acquisition Regulation (FAR)
- Experience in HHS Purchase Card programs and policies
- Experience in working in HHS wide systems (UFMS, etc)
- Communicating with staff at all levels of a federal organization including but not limited to Agency Executives, Directors, Deputy Directors.

Education Transcripts
