Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices are safe, and effective.

The mission of Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over the counter and prescription drugs, including biological therapeutics and generic drugs.

The Office of Strategic Programs (OSP) serves the Center Director, and the super office directors who lead major operations involved in regulatory oversight of human drugs. OSP's functional capabilities include strategic planning and management, negotiation with major external stakeholders over future work commitments and resource commitments, and process and program design and management.

The mission of the Analytics and Data Services Staff (ADSS) is to serve as the Center's technical experts in the development of specialized and informative management and performance reports and to be the primary reporting source for all reporting on new drugs, biologics, biosimilars and generic drug review programs. ADSS also conducts qualitative and quantitative analyses (e.g. risk analysis, statistical modeling and machine learning techniques) to support CDER senior management in their decision making.

Duties/Responsibilities

As an **Operations Research Analyst**, the incumbent will conduct and/or participate in the analysis of program policy and operations. This work will provide a basis for, and have a direct effect on, decisions affecting major Center regulatory policies and programs. The incumbent will utilize tools and techniques and other appropriate analytical methodologies from disciplines such as data science, operations research, statistics, economics, computer science and decision science.

Band A:

- With guidance and support from project team members, reviews relevant data sets and understands appropriate methods for analysis, and/or communicating results to inform decision-making.
- With guidance from director and employees of higher grades, applies proper techniques and tools to conduct an analysis of given data/information and respond appropriately to questions and/or requests from customers to provide insight to decision makers.

Band B:

- Compiles, analyzes, and reports data using different analytical and statistical techniques in order to solve problems and as needed to develop relevant predictions across the Center. These techniques include, but are not limited to, statistical modeling, feature engineering, machine learning, predictive modeling, and data mining.
- After completing customer engagements, develops benchmarks or other metrics to

individually conduct impact assessments and determine whether the desired outcomes were attained.

Band C:

- Independently collects, reviews, and analyzes unstructured or structured quantitative and qualitative data related to specific programs/policies/initiatives from disparate sources (i.e., using appropriate querying tools), reviews it for integrity and validity, and investigates its merit, worth, and/or signification in order to deliver clean, clear, useful, and correct data to internal customers for analysis and decision making.
- Develops more complex set of methods and/or models (e.g., functions, documenting code, machine learning and data mining algorithms) to complete an analysis. Determines the appropriate time to apply proper technical language and appropriate algorithms within specific programs and systems (i.e., SQL, OBIEE, Statistical Analysis System (SAS) Python, R) so they may create desired outputs to solve a challenging defined customer problem.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.

Degree: in Operations Research; or at least 24 semester hours in a combination of operations research, mathematics, probability, statistics, mathematical logic, science, or subject-matter courses requiring substantial competence in college-level mathematics or statistics. At least 3 of the 24 semester hours must have been in calculus.

Our ideal candidate will possess:

- Educational training and experience in such fields as statistics, mathematics, data science, operations research or similar computationally intensive fields providing the skills necessary to serve as an operations research analyst.
- Experience in applying the principles, concepts, tools, and methodologies related to business intelligence, data reporting, data analysis and operations research.
- Experience with SQL, R, and Python programming languages.
- Demonstrated skill and experience developing complex queries and high-quality analytical work products in support of program operations and policies.
- Demonstrated ability to work independently and collaboratively across organizational boundaries.

Education Transcripts
